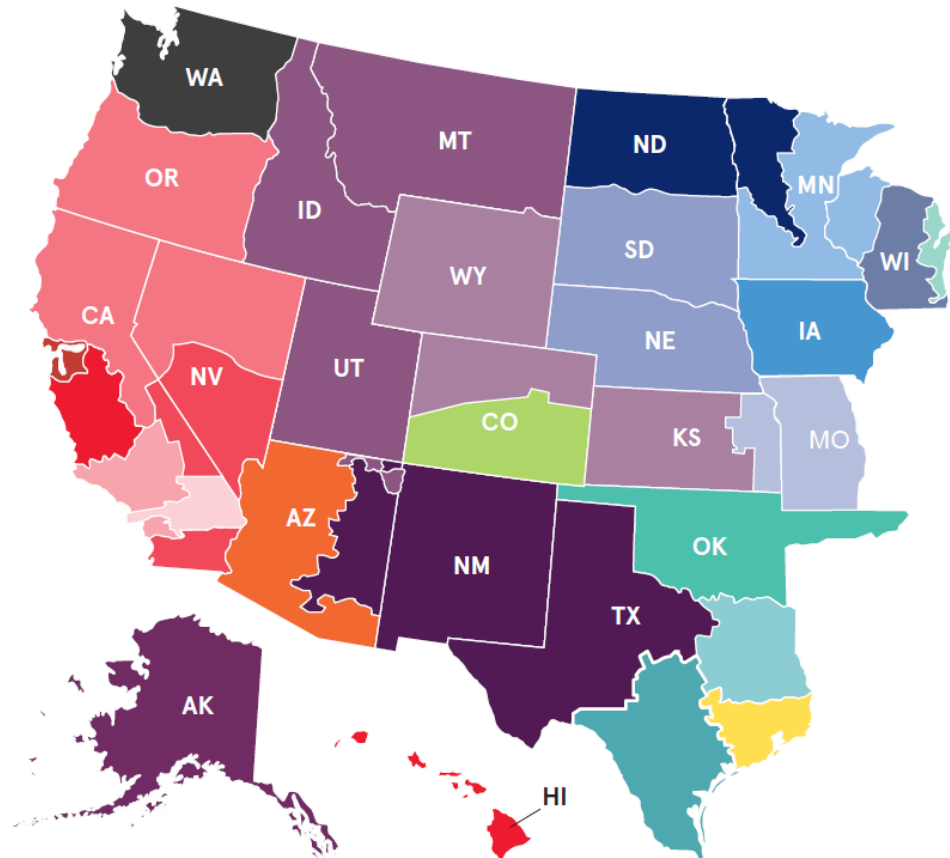


Territory map
