

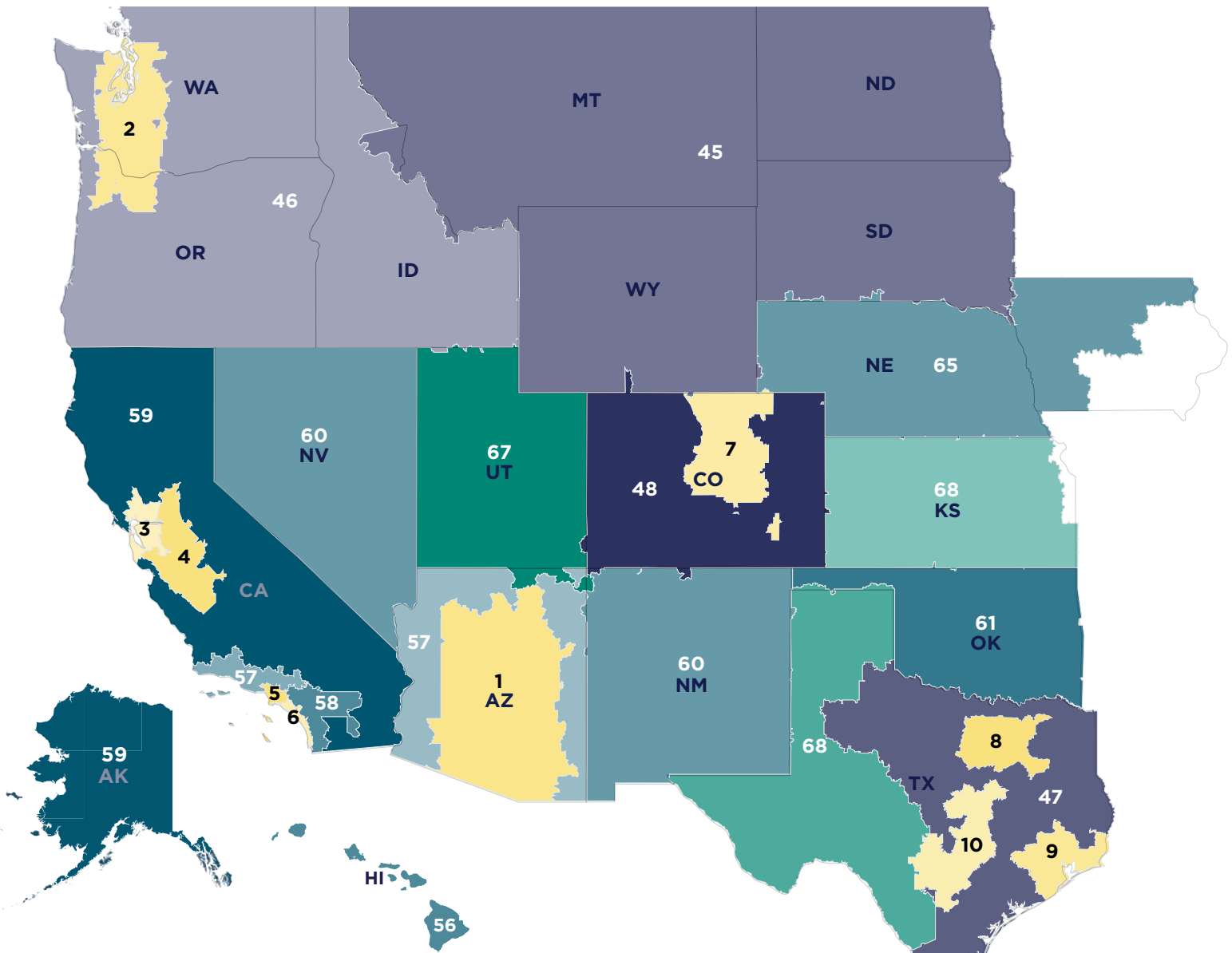

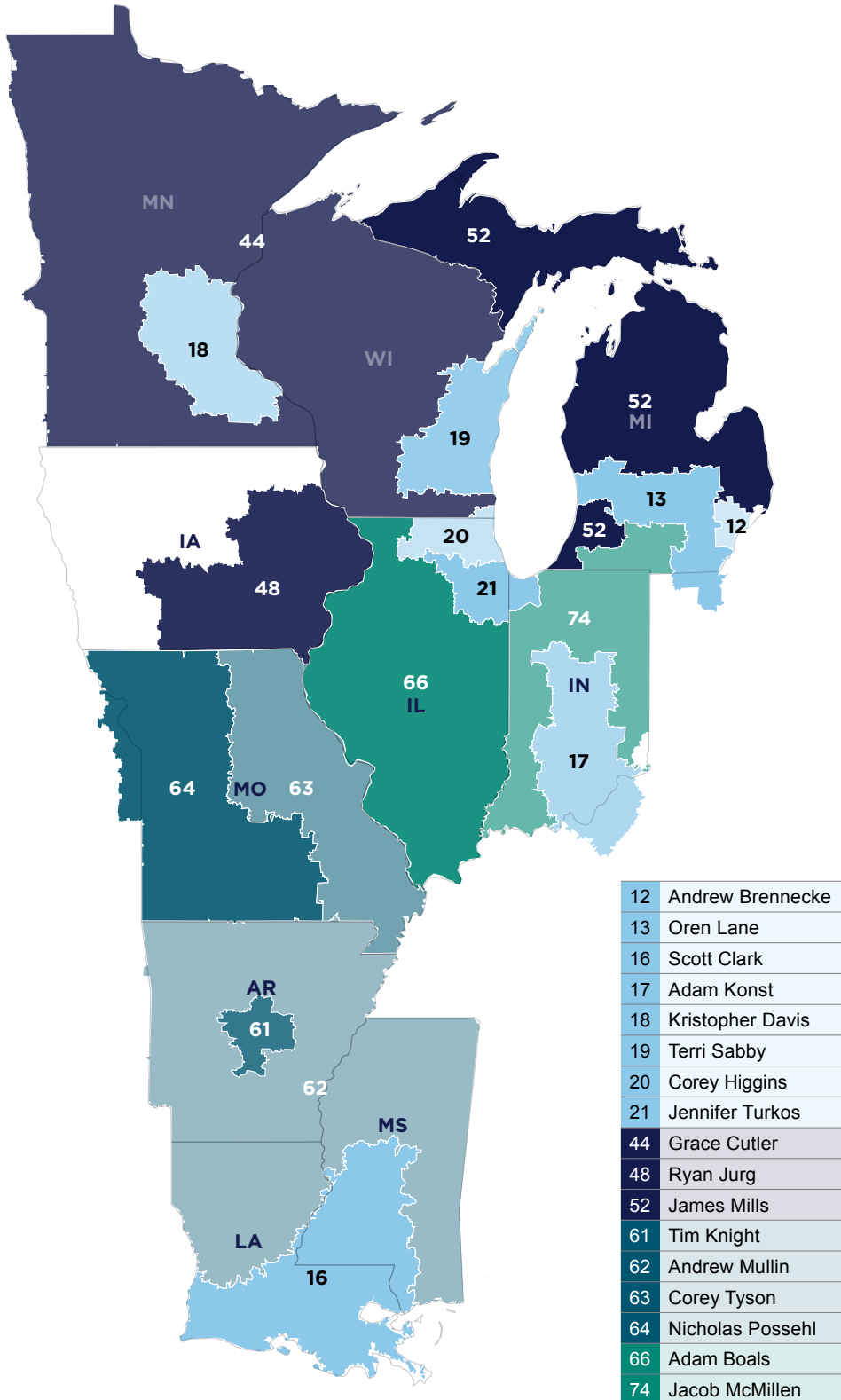

Brokerage Annuity Distribution



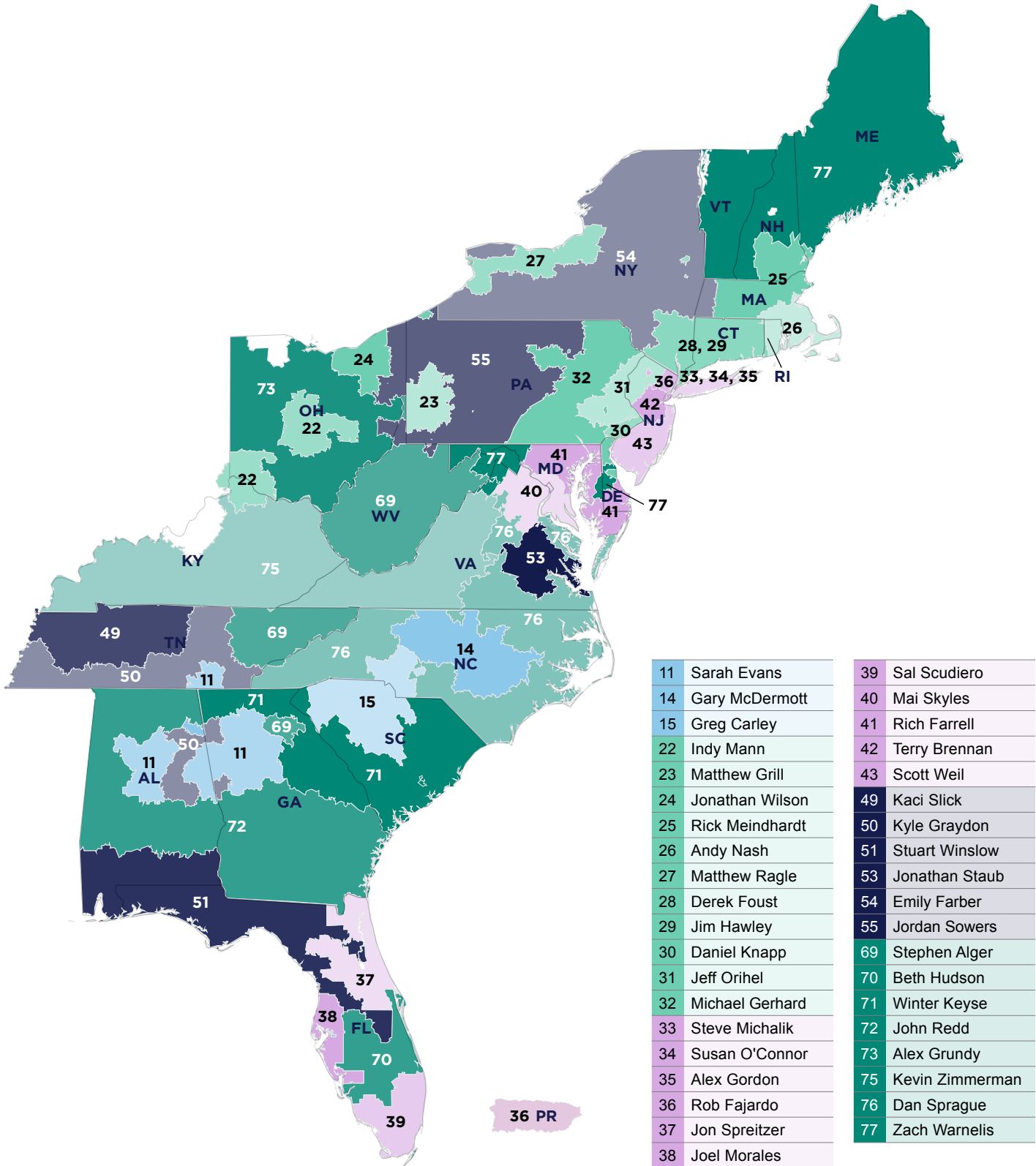
