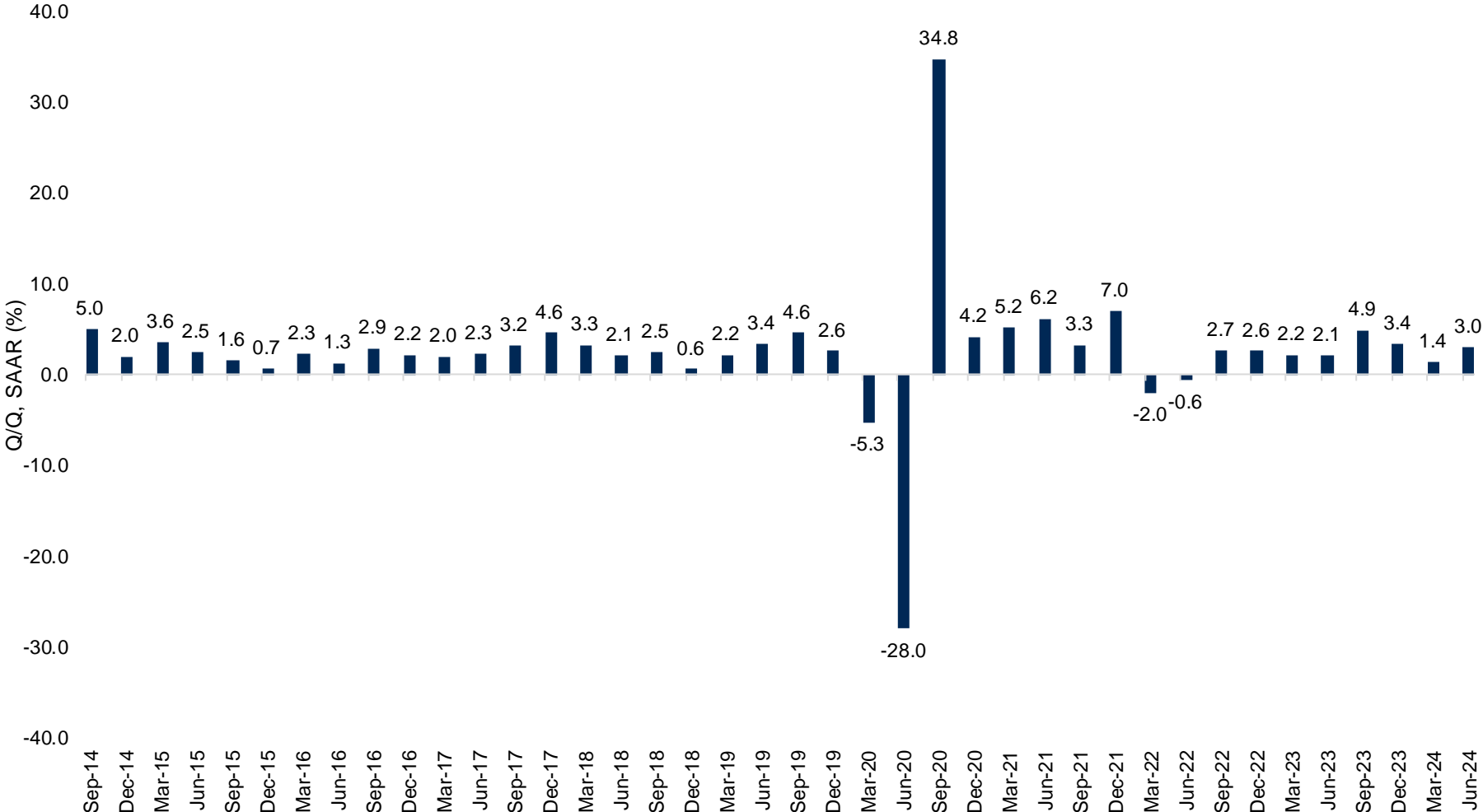

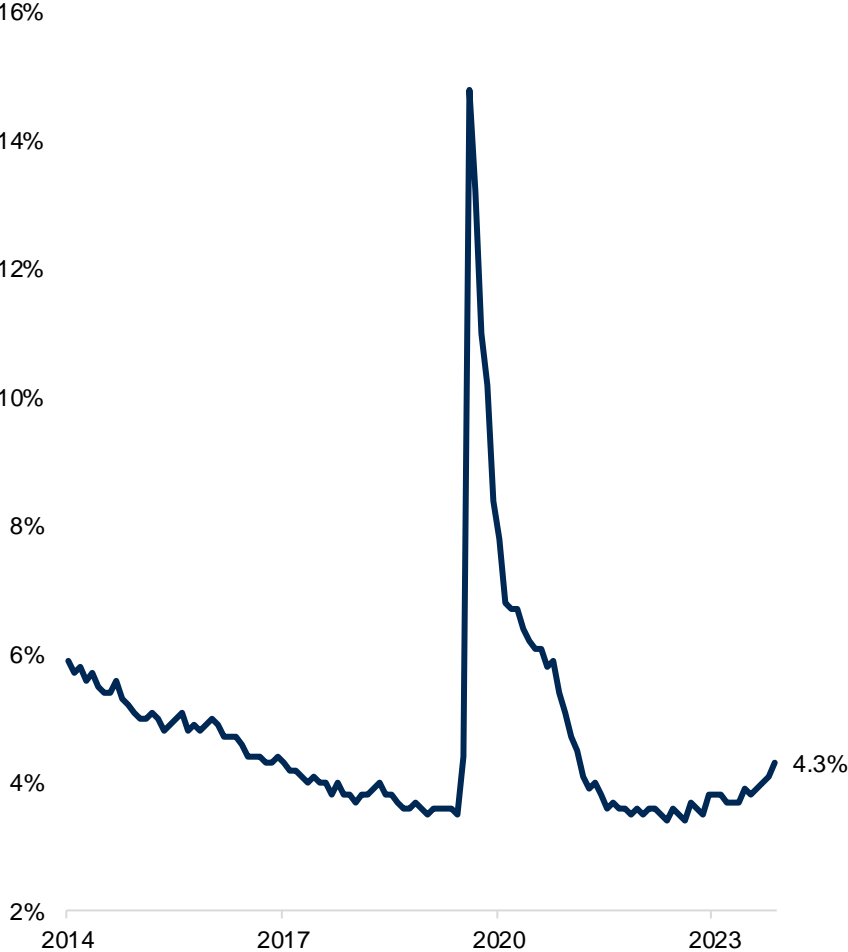
U.S. Real GDP Growth



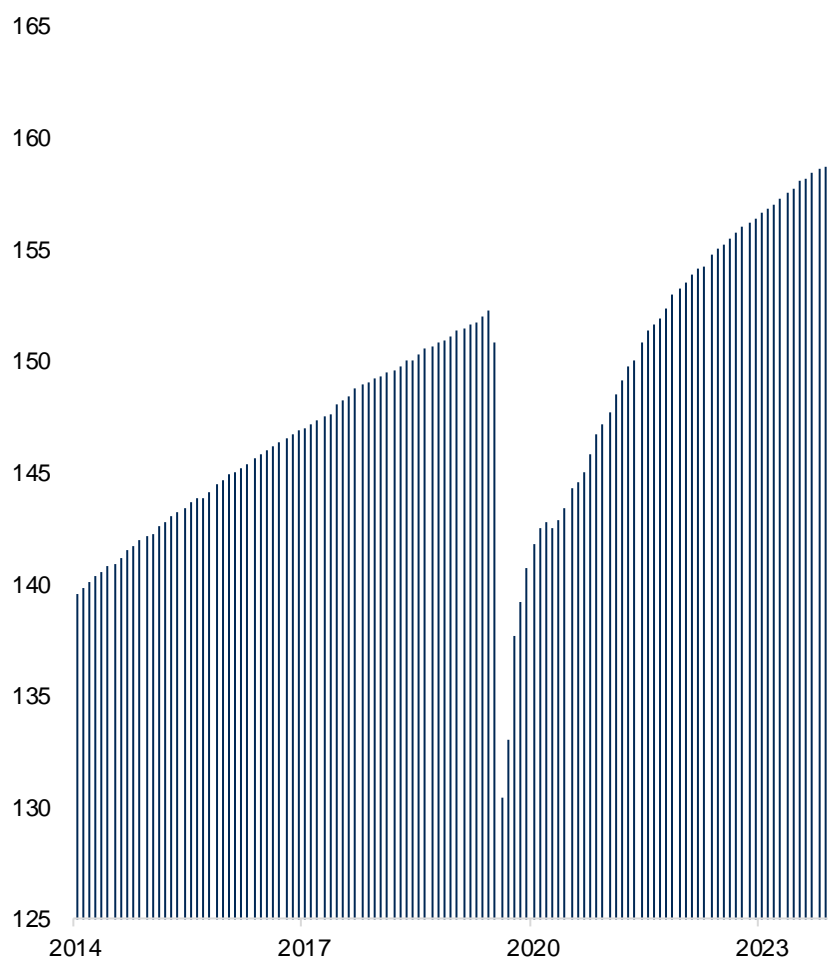

Total Non-Farm Payrolls (Millions, Seasonally Adj.)

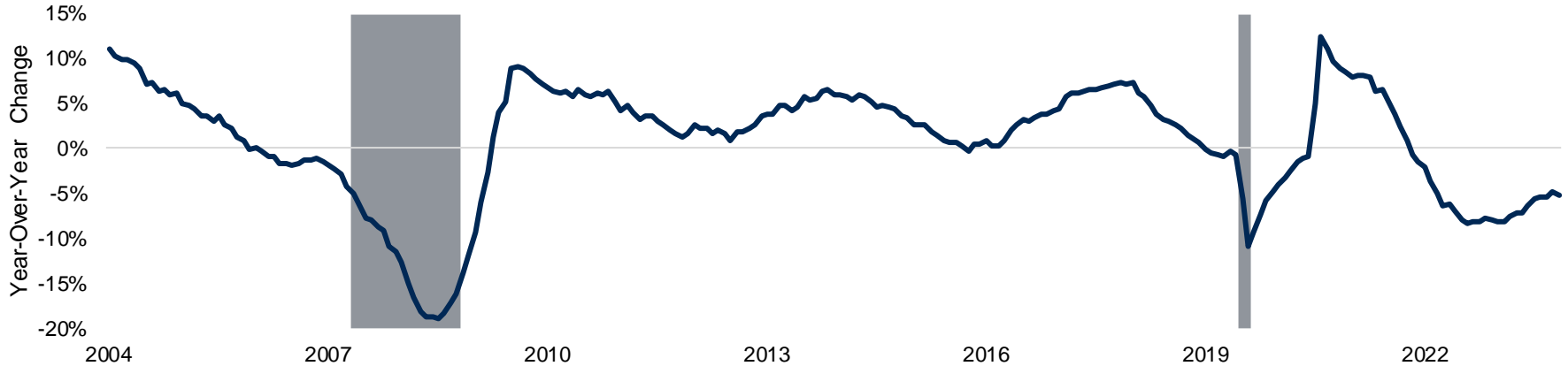

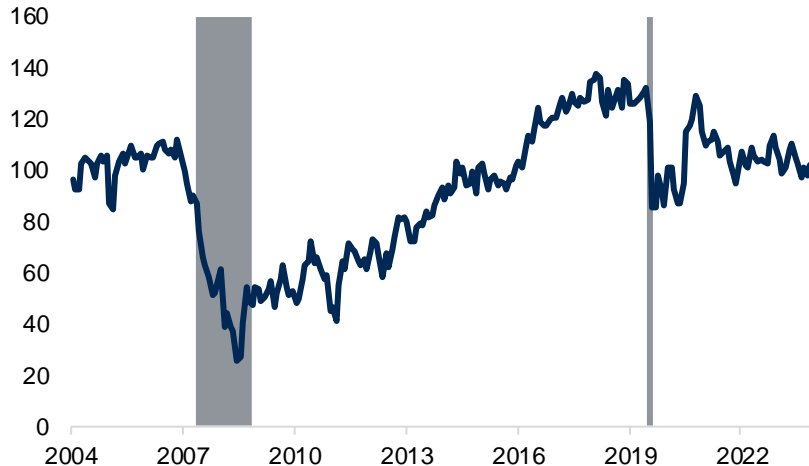

U.S. Leading Economic Indicator Index



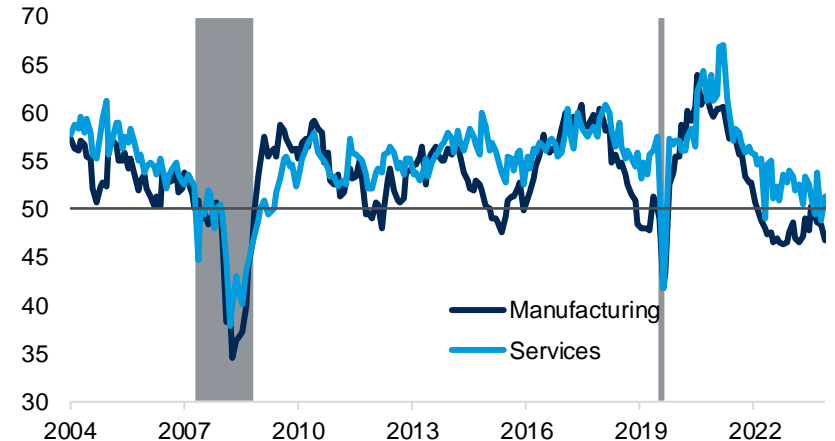

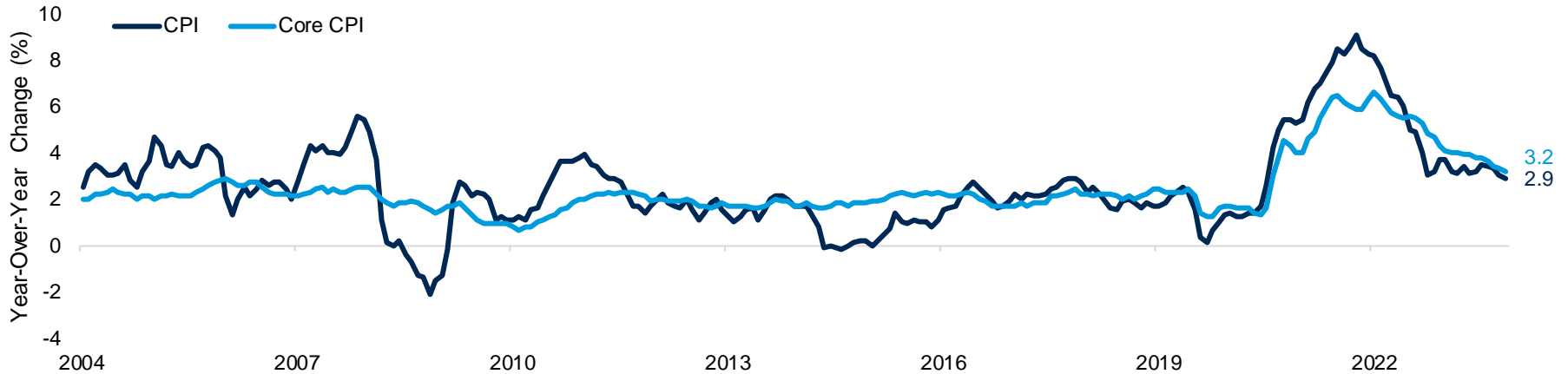
U.S. ISM PMI Levels

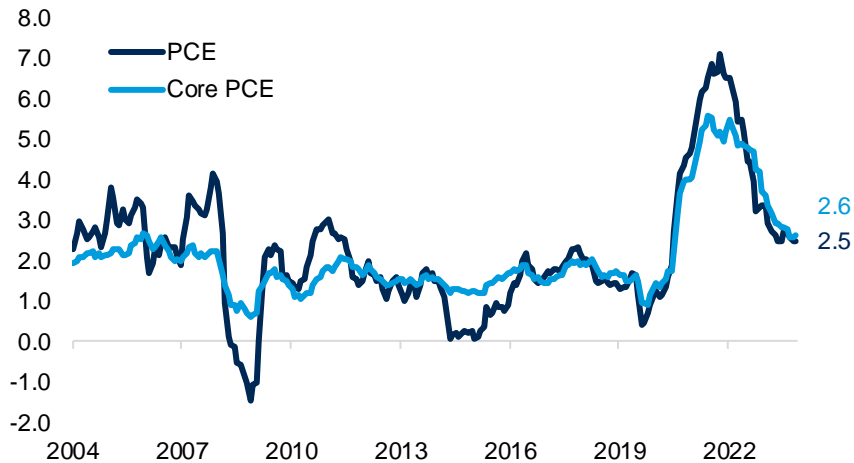

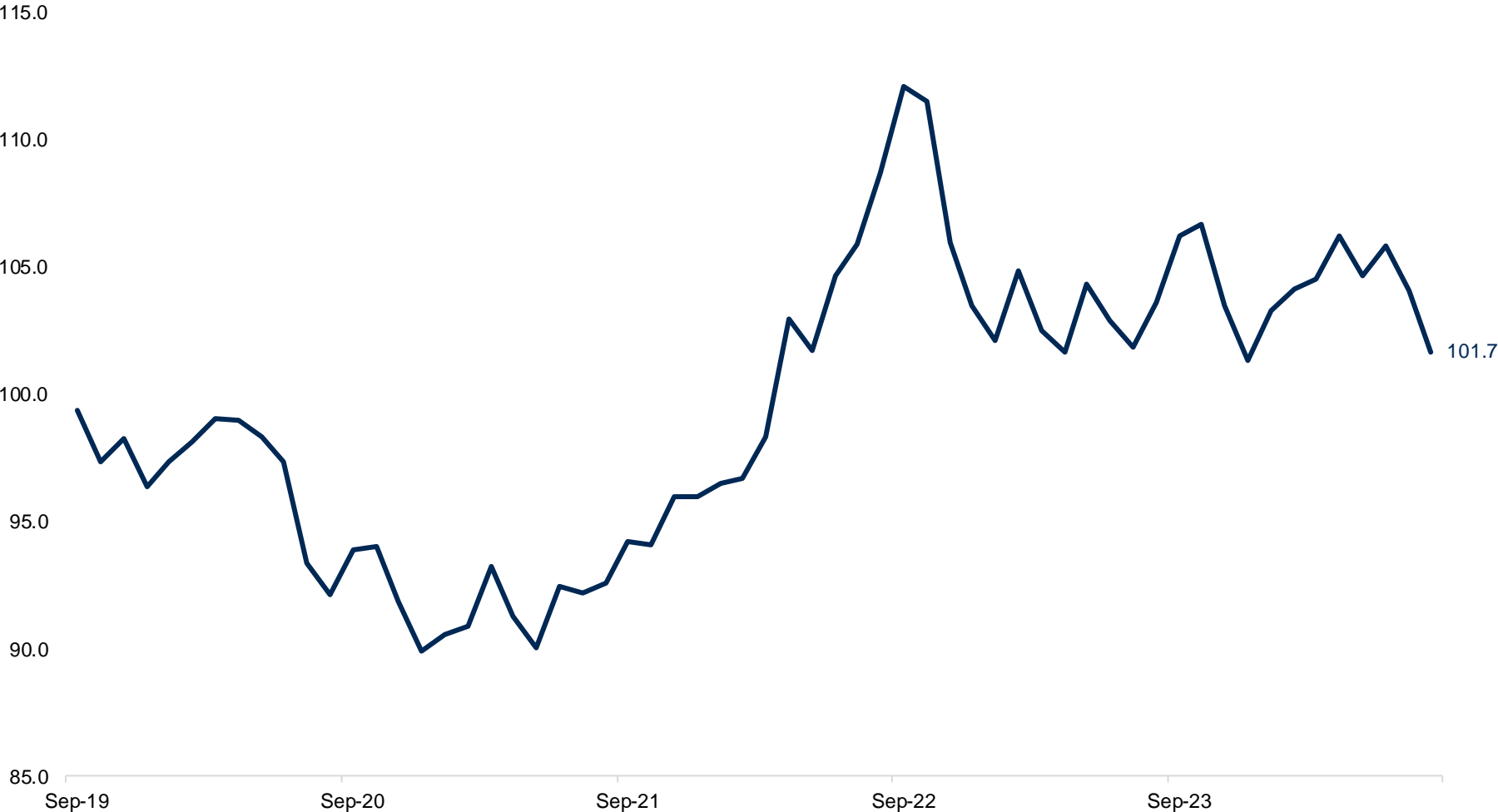
U.S. Breakeven Inflation

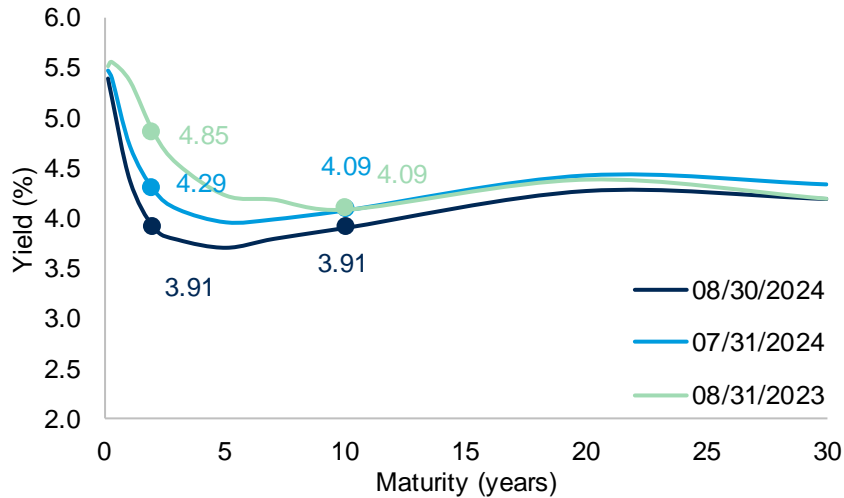

U.S. Treasury Yield Curve



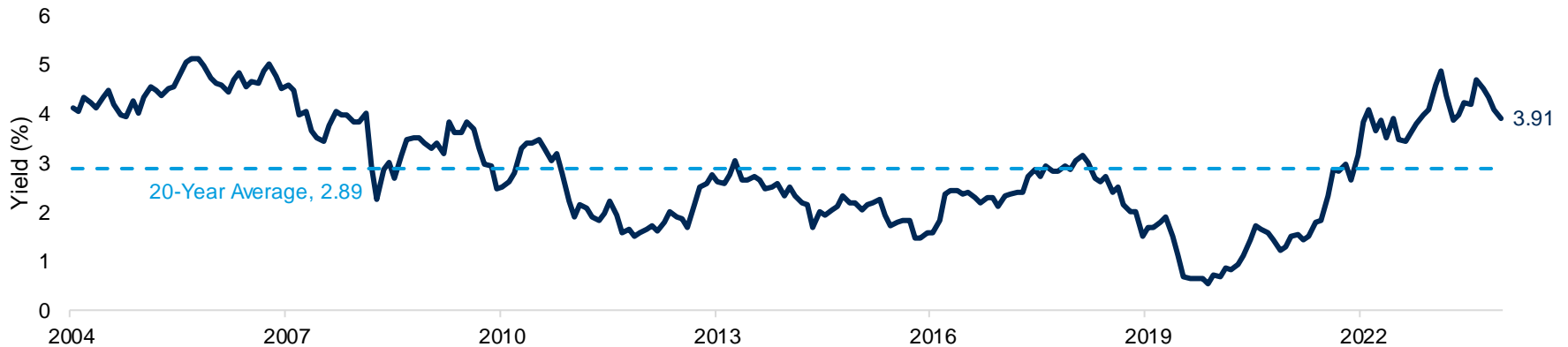

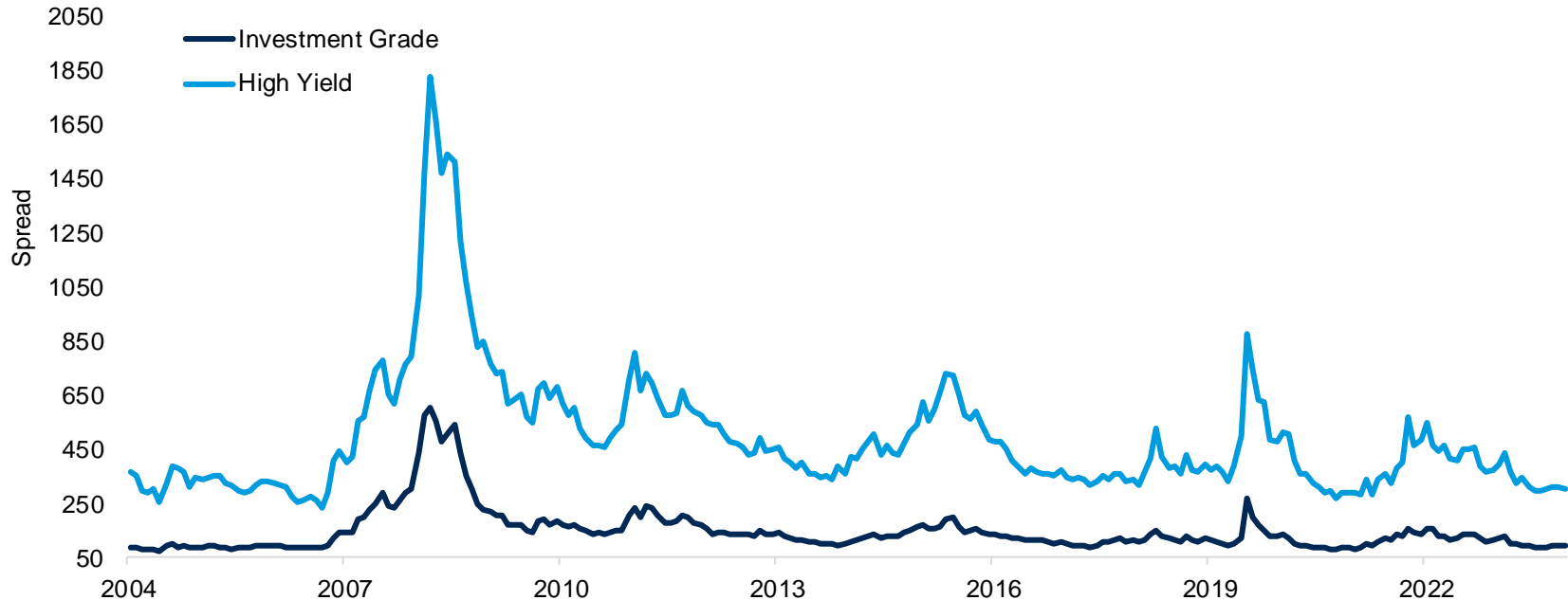
U.S. 10-Year Treasury Yield

Bloomberg Corporate Bond Index Spreads (bps)



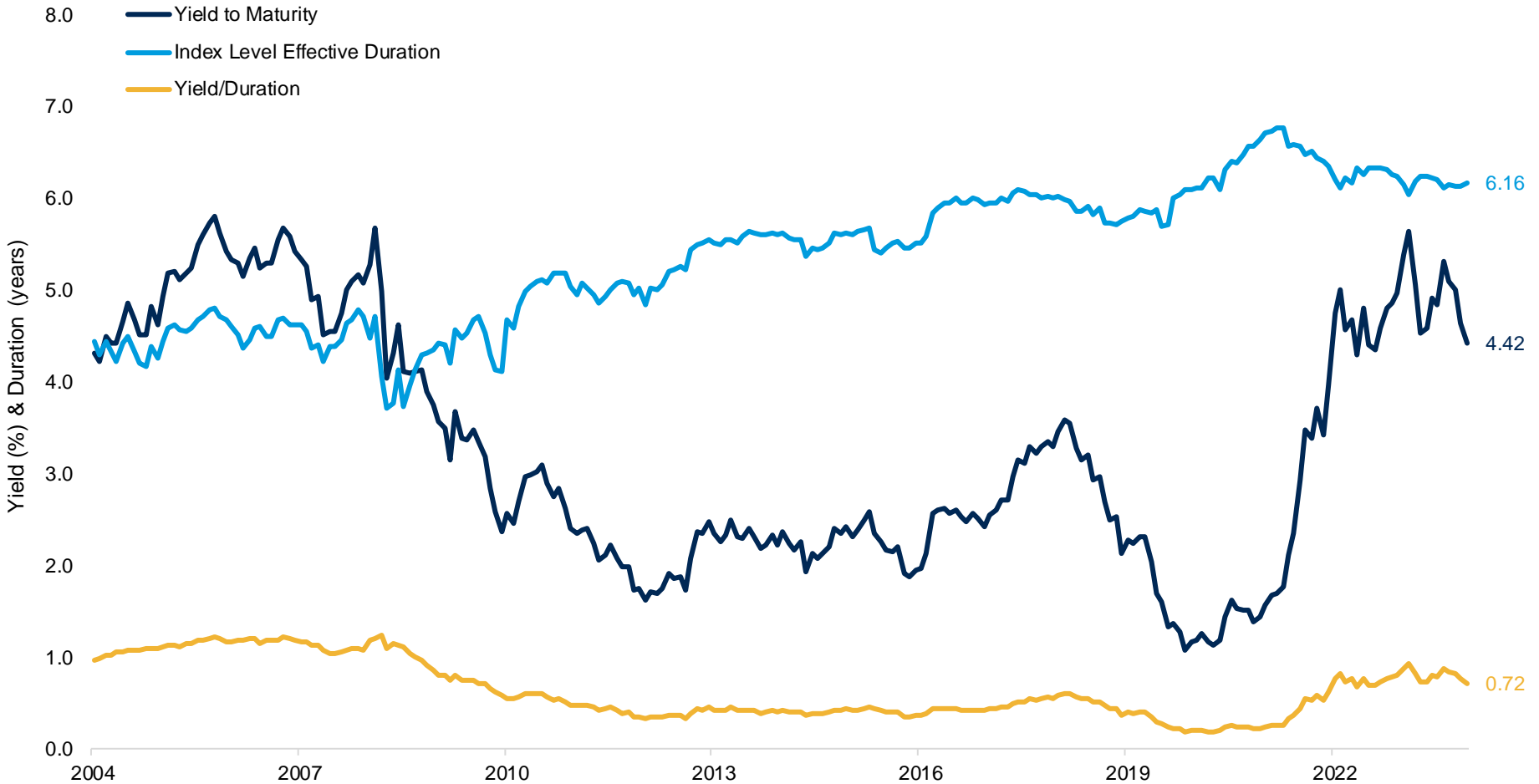

Bloomberg US Aggregate Bond Yield and Duration

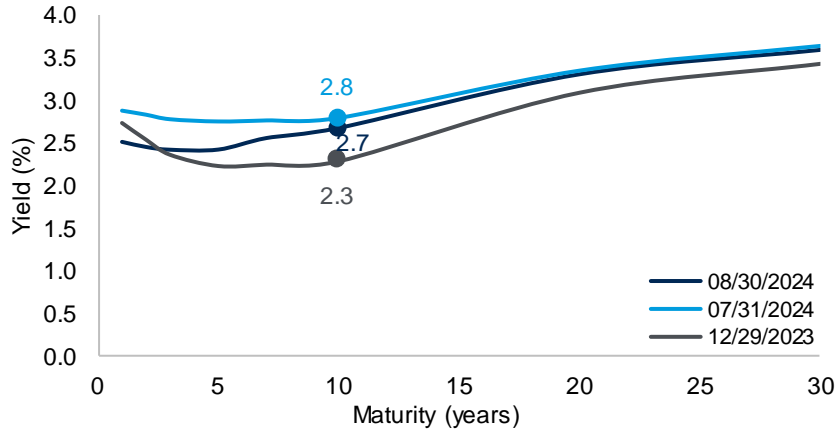

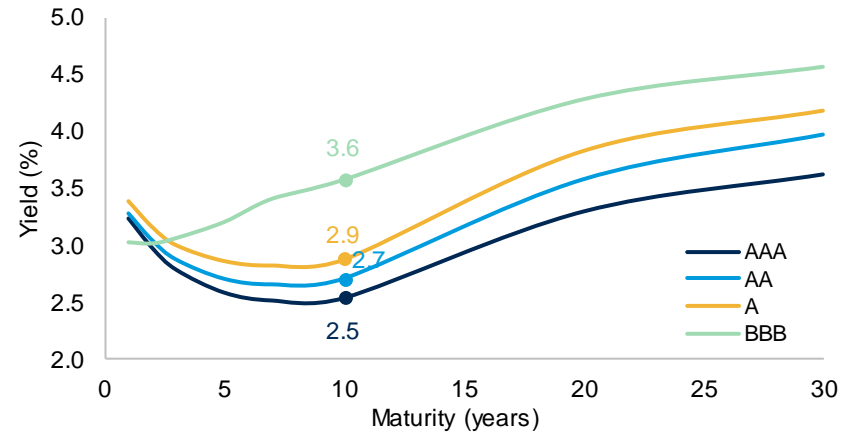

S&P AAA Muni Yield Curve



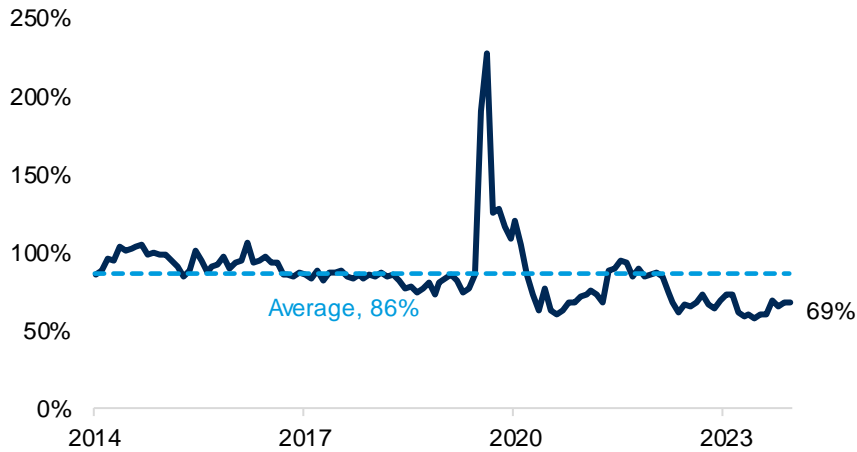

S&P U.S. Muni Curves



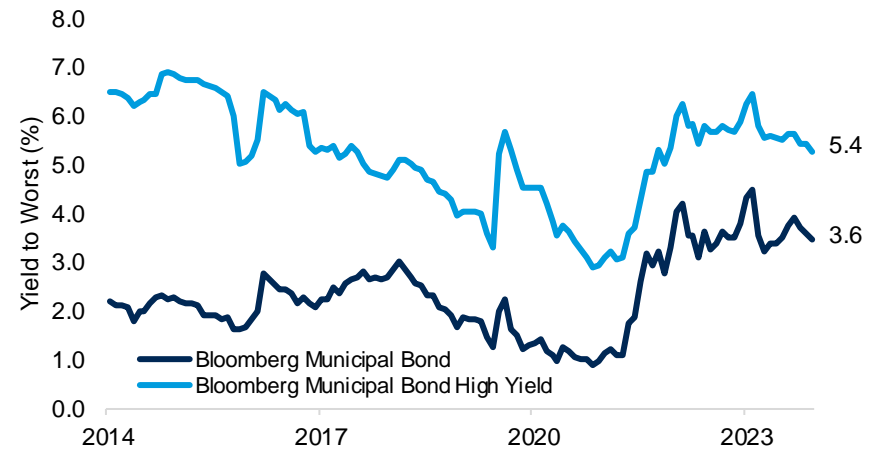

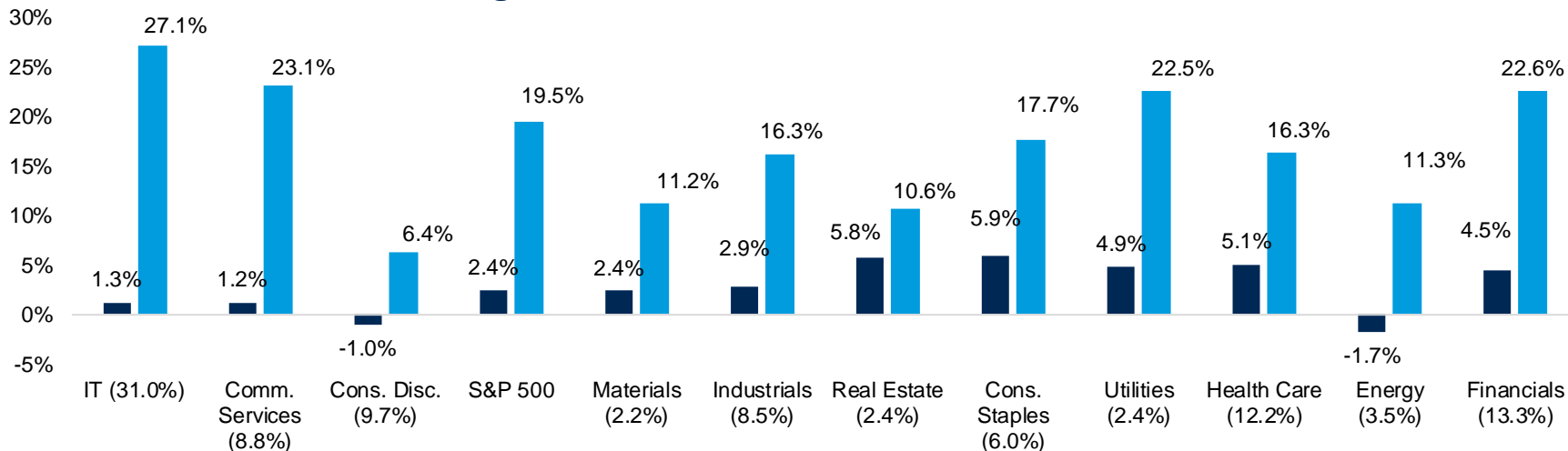

S&P 500 Sector Returns (and Weight in Index)

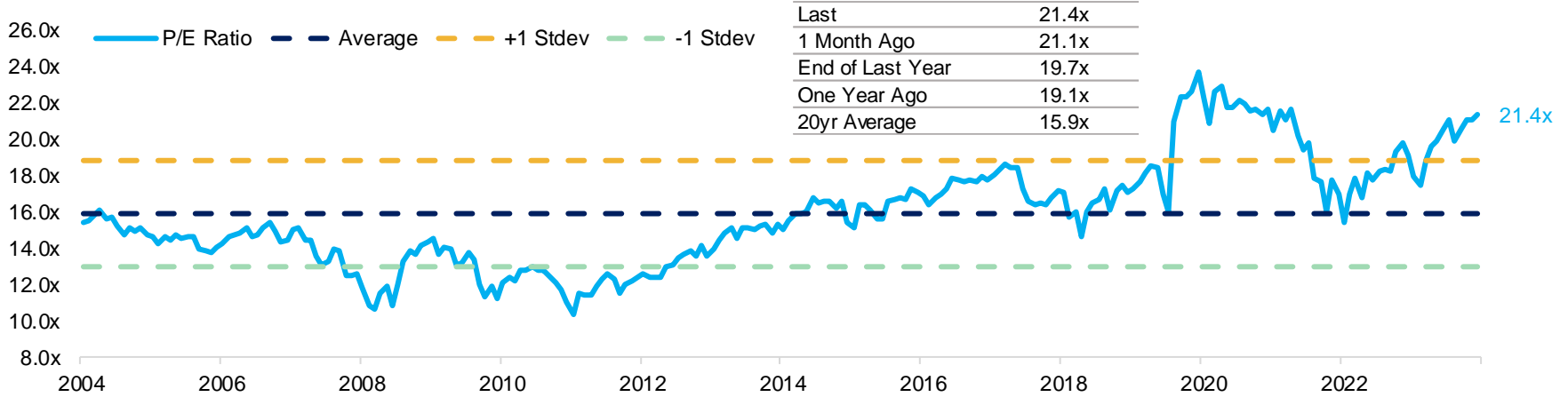

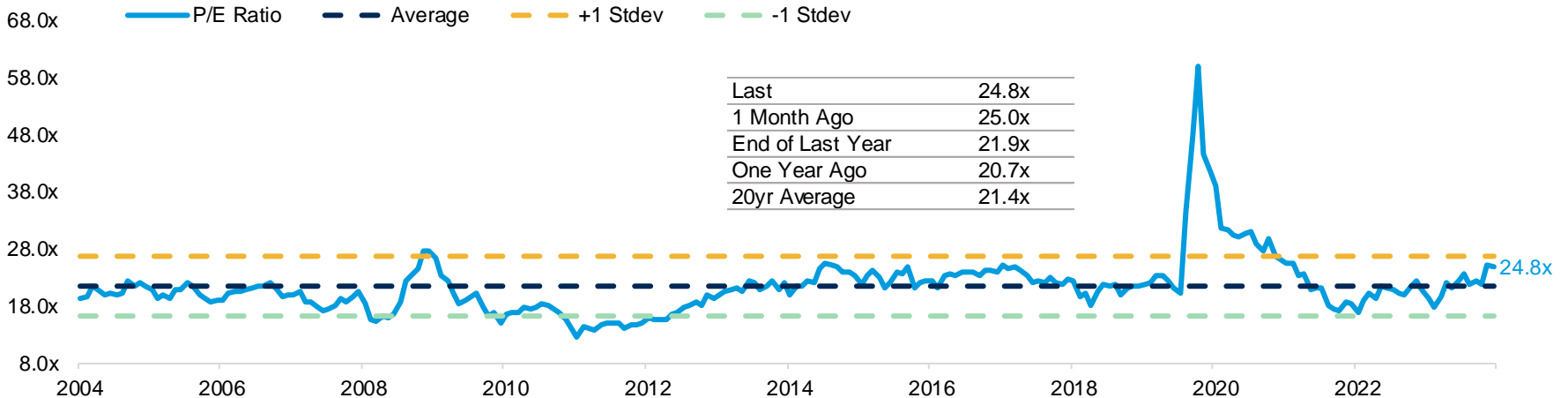
Domestic Equity – P/E Ratios

S&P 500 Earnings Decomposition

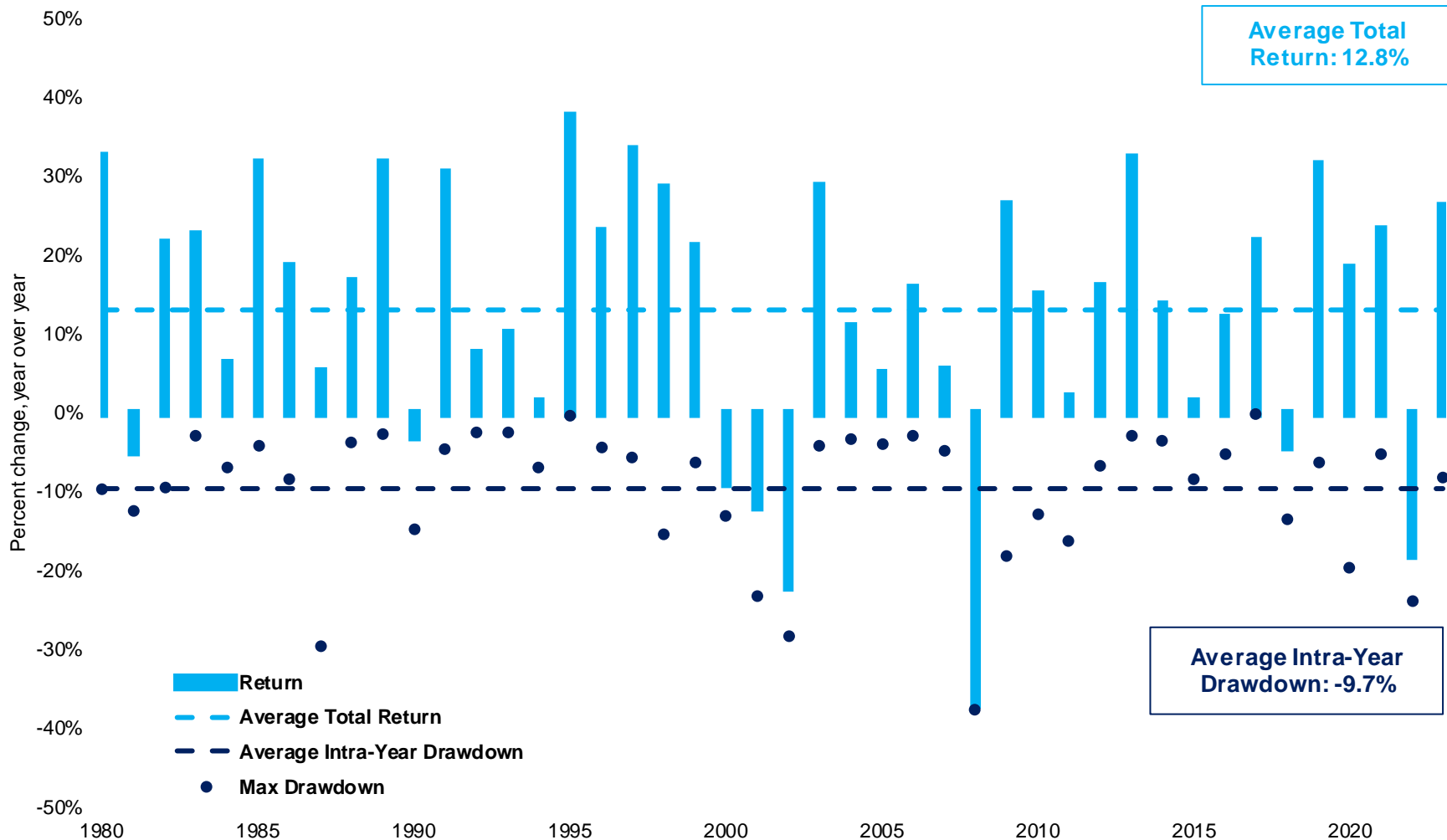

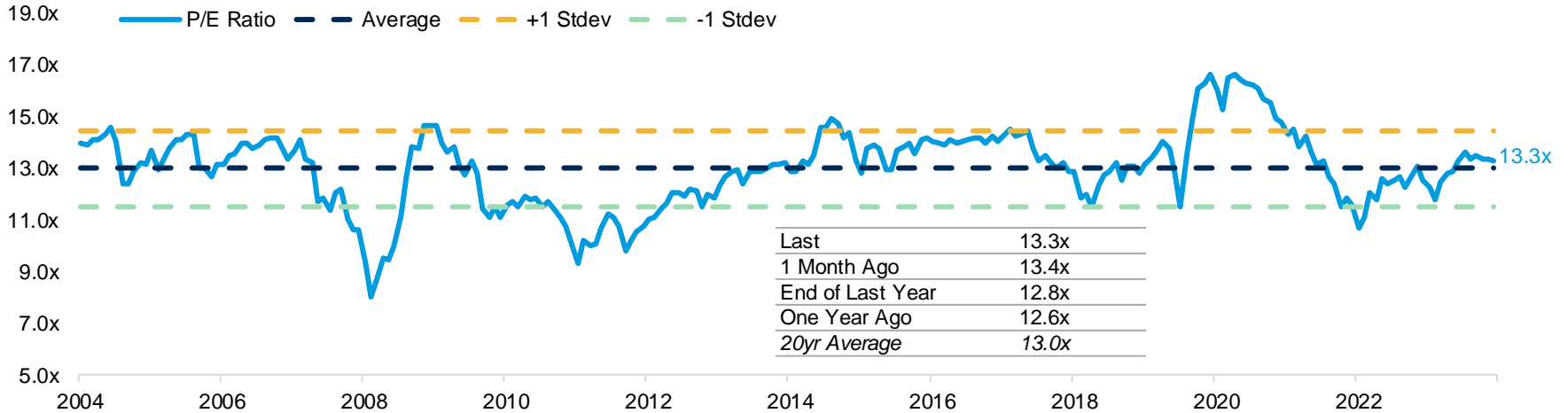

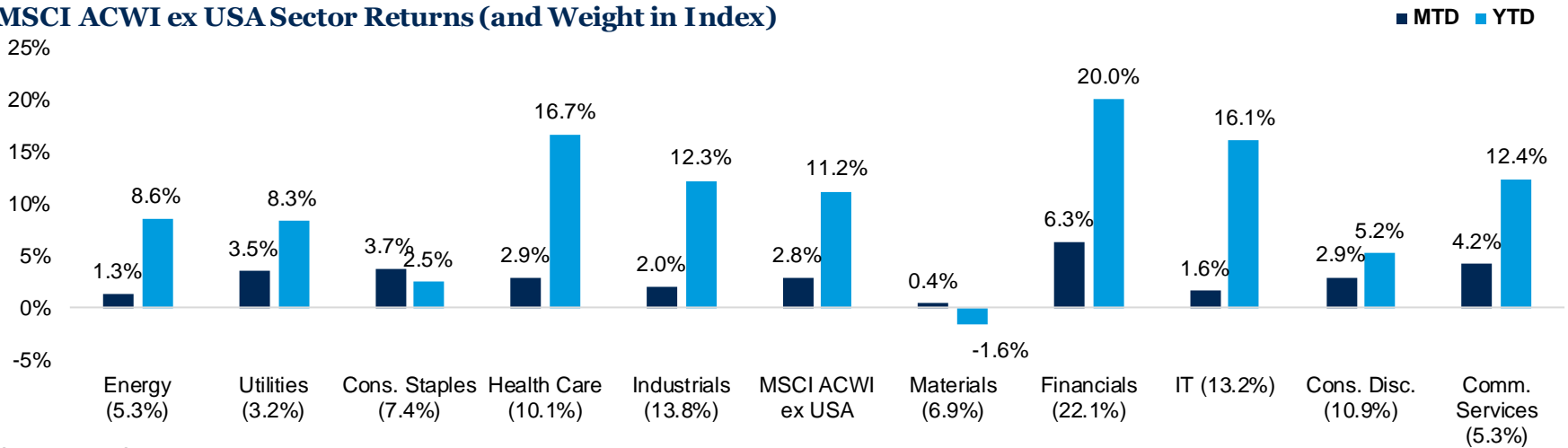

MSCI ACWI ex USA Sector Returns (and Weight in Index)

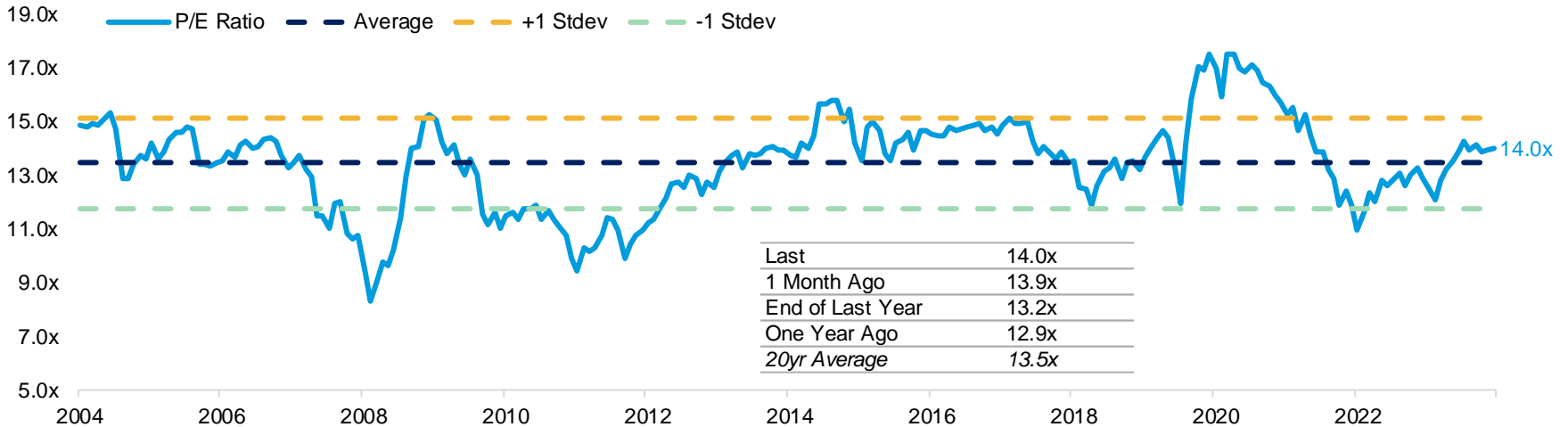

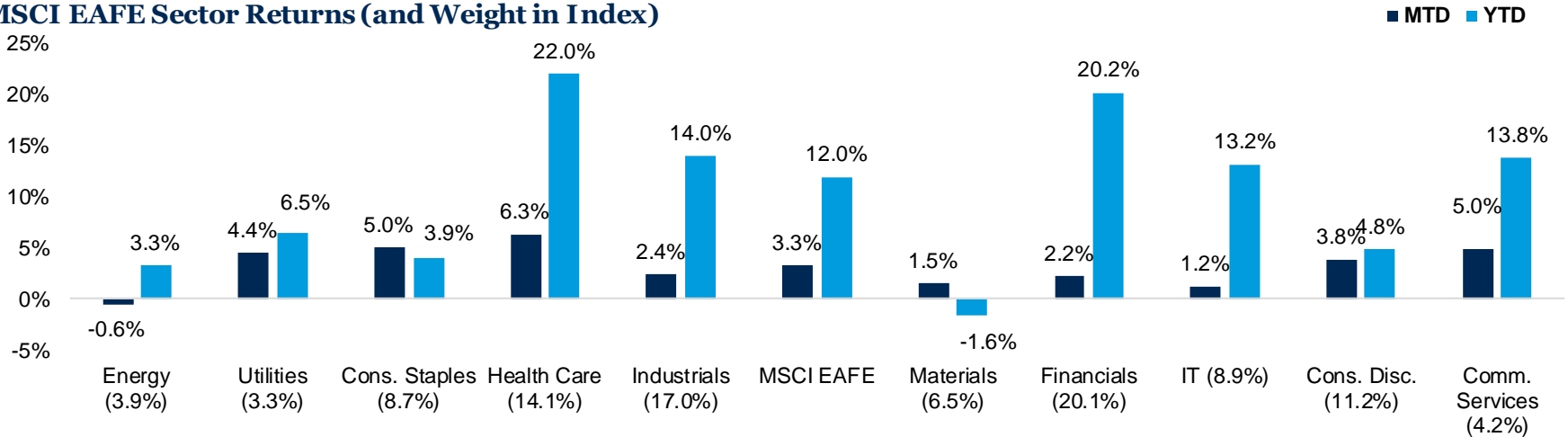

MSCI EAFE Sector Returns (and Weight in Index)

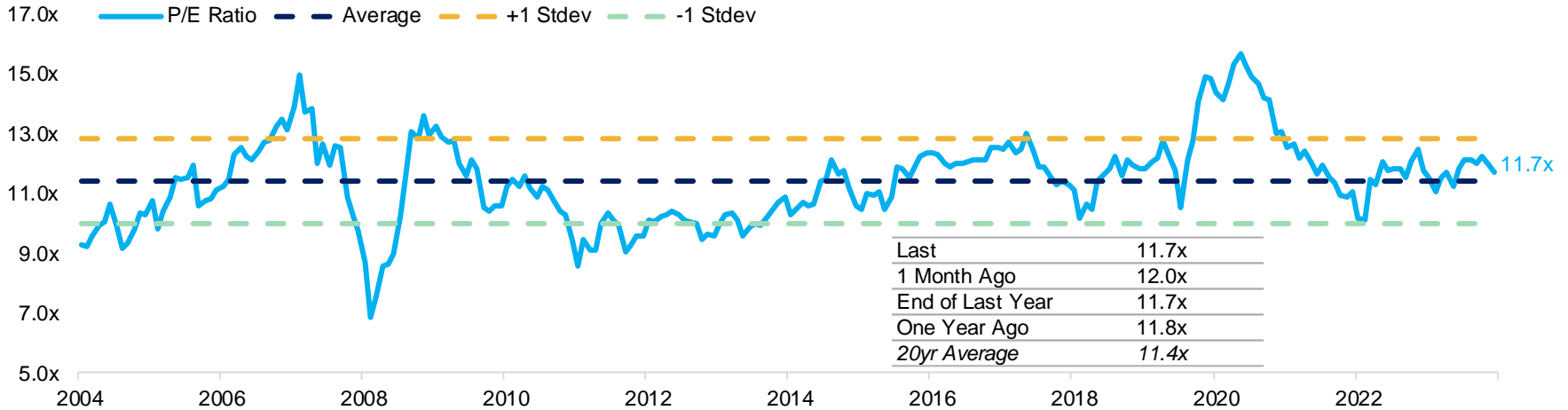

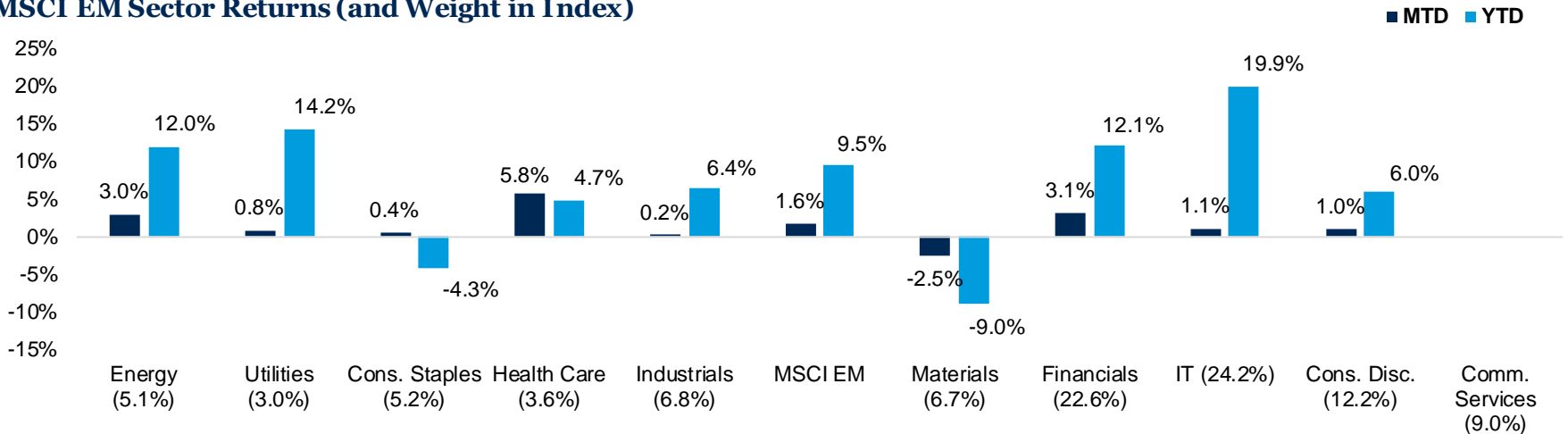

MSCI EM Sector Returns (and Weight in Index)

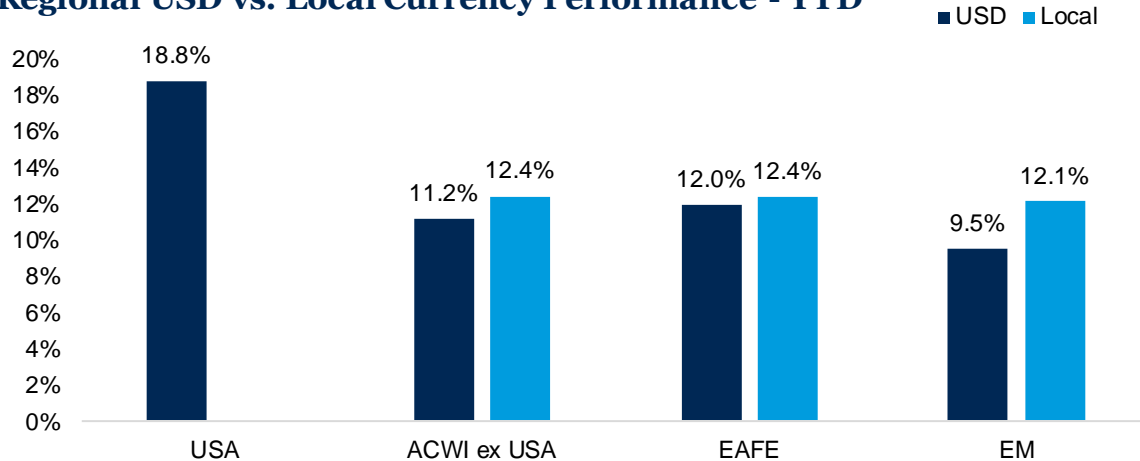

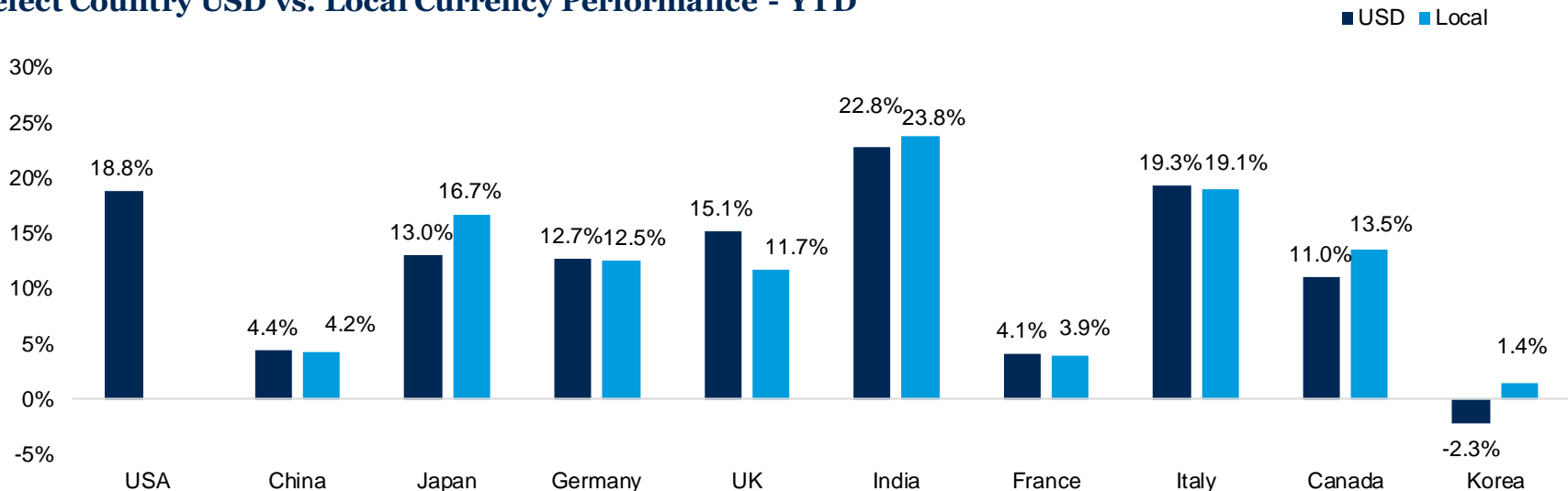
U.S. Dollar vs. Local Performance

Select Country USD vs. Local Currency Performance - YTD

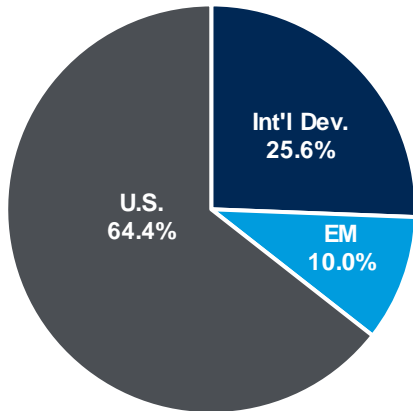

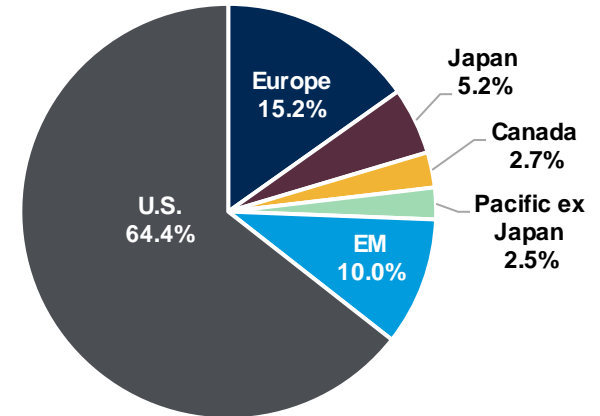

MSCI AC World Index Regions



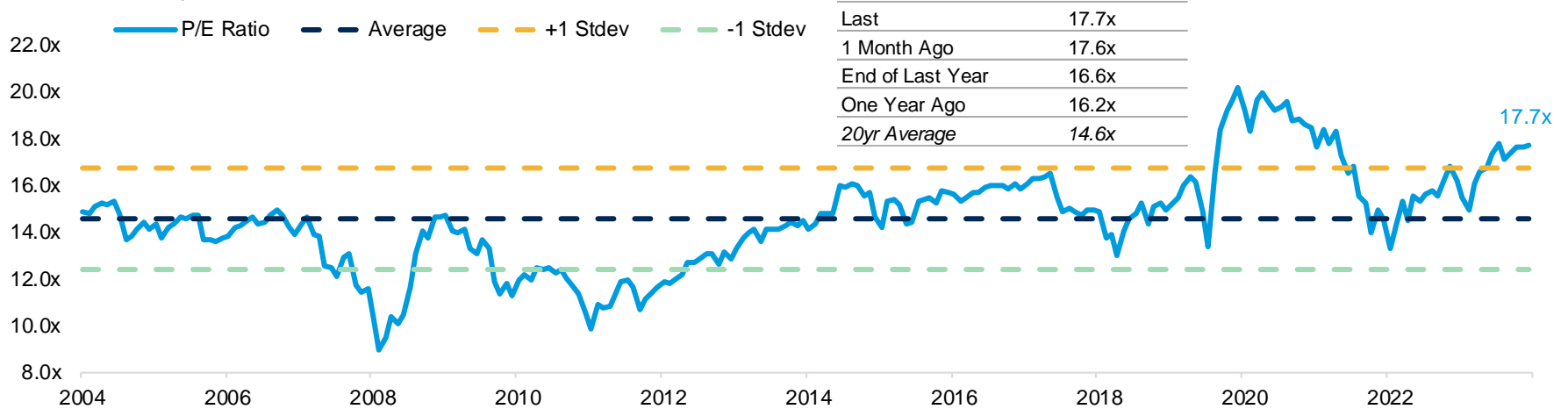
MSCI AC World Index Detailed Regions

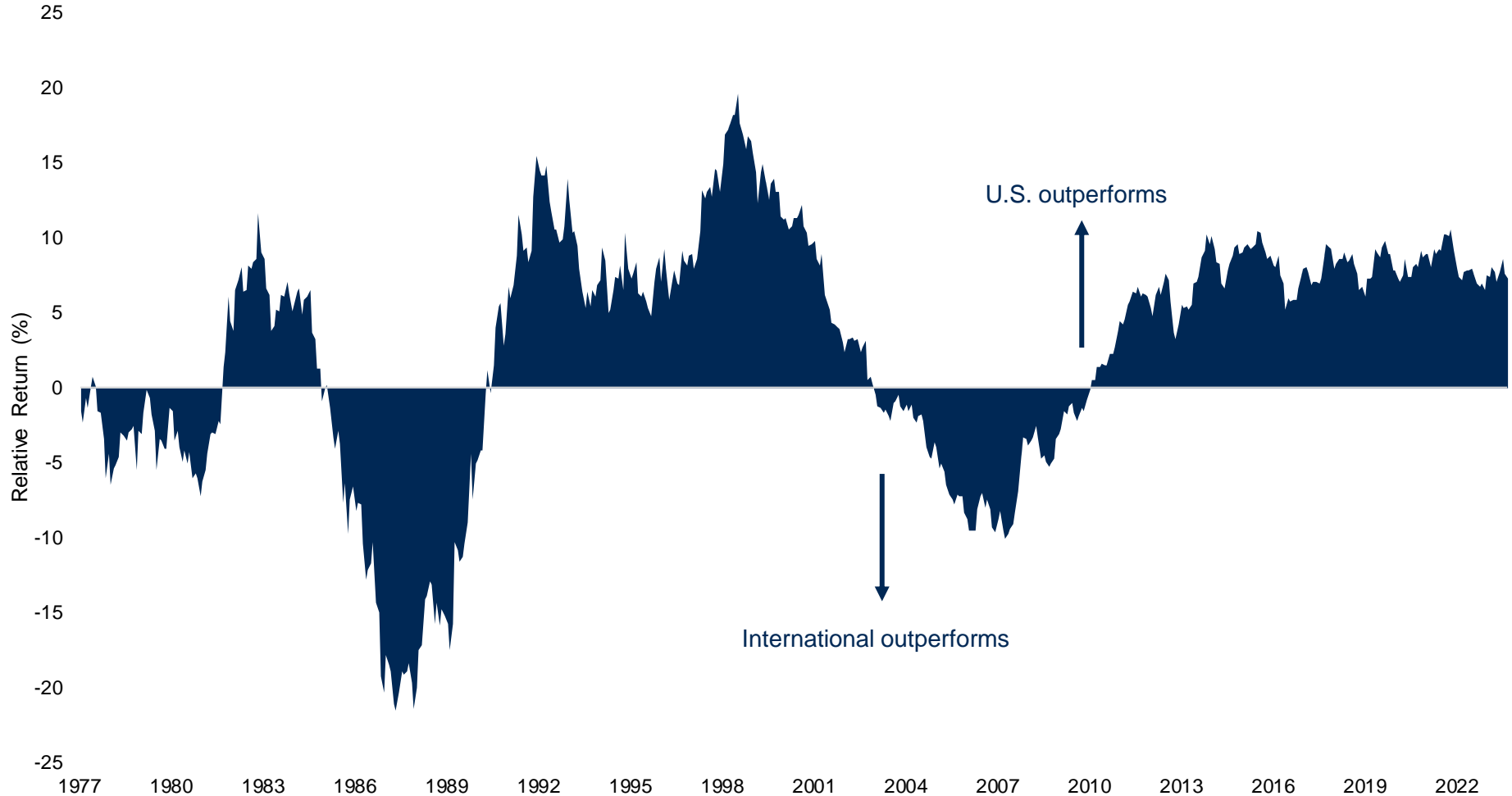

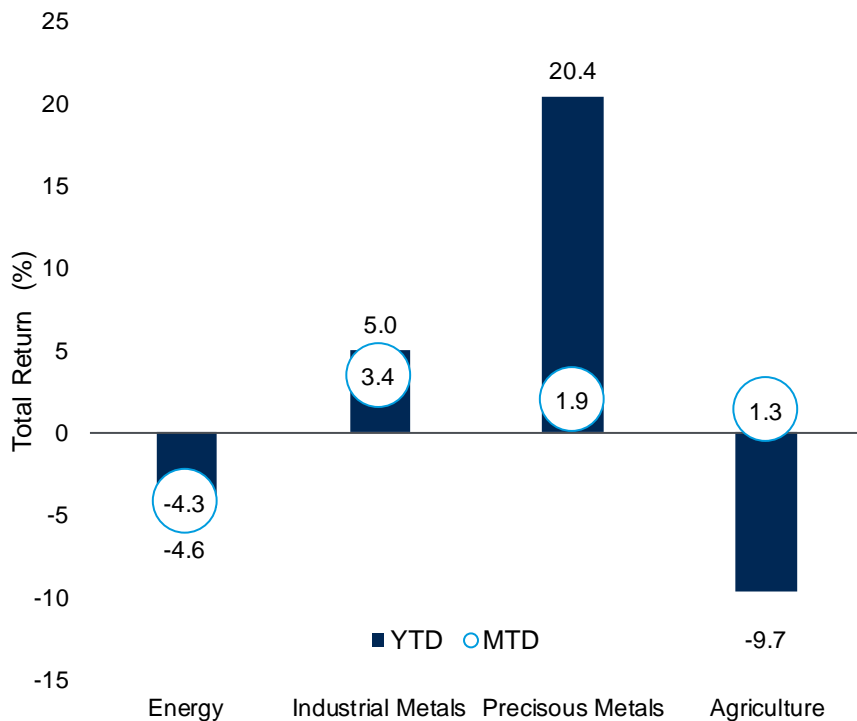

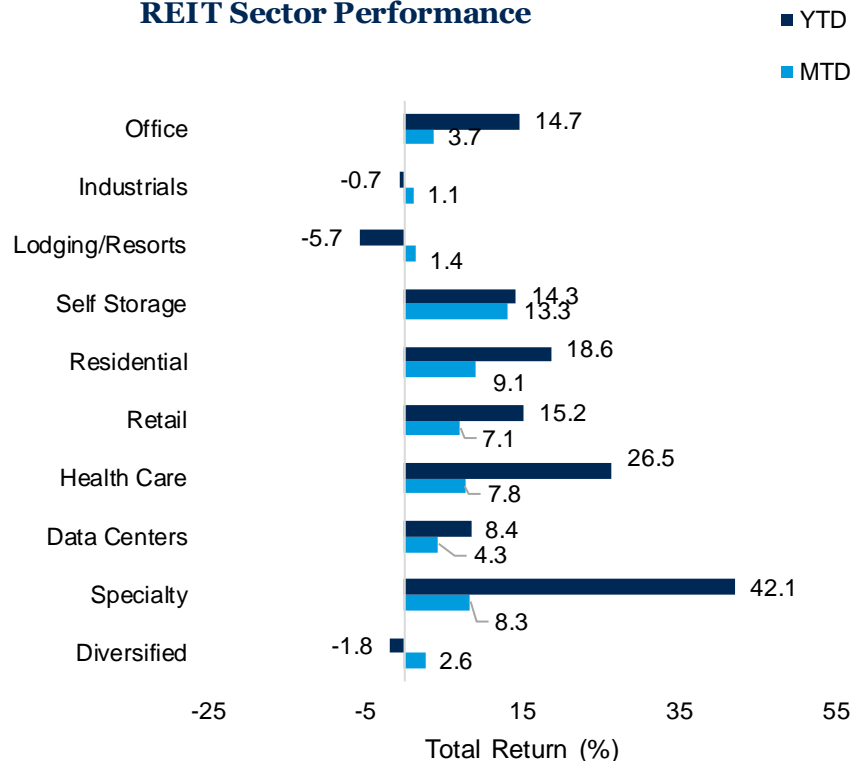

REIT Sector Performance

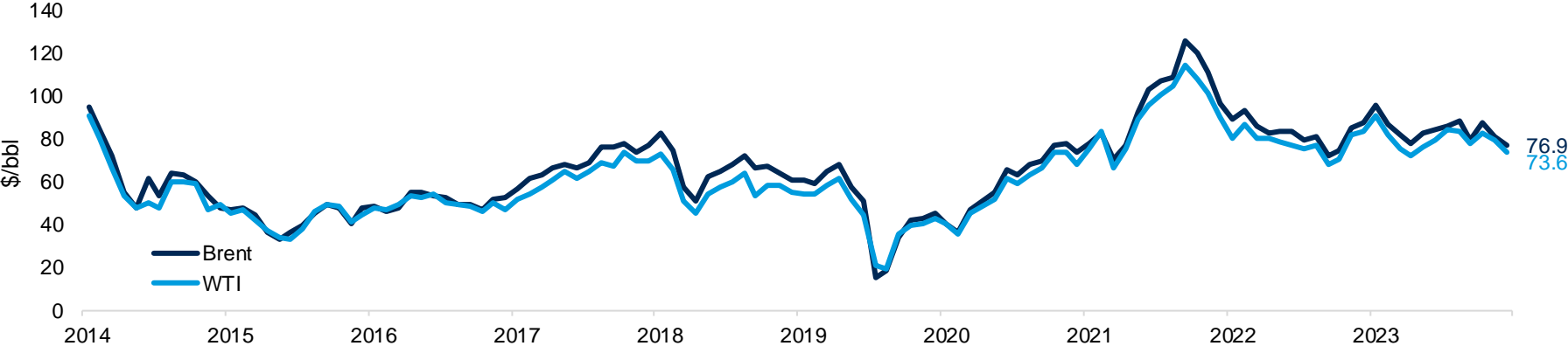

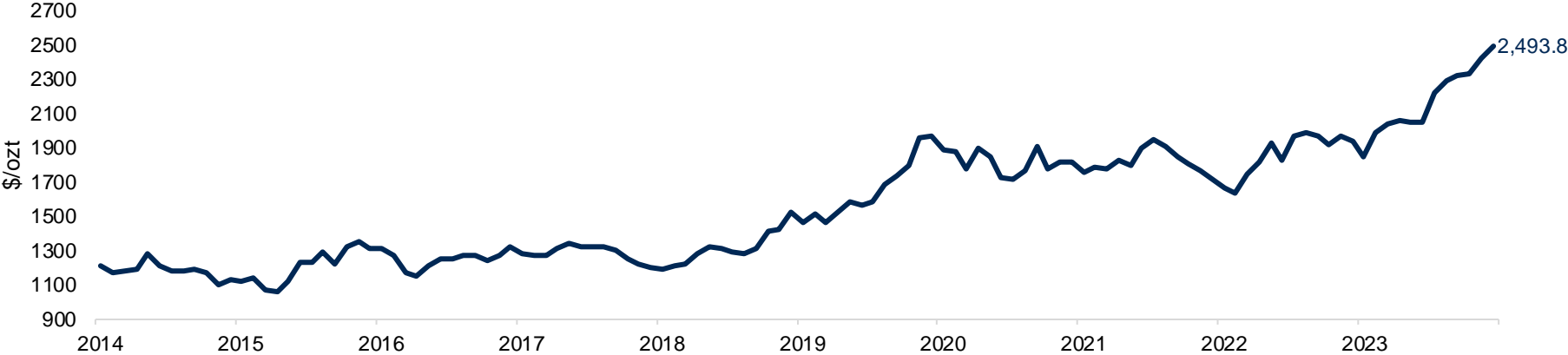
Oil and Gold Prices

Fixed Income

- **Bloomberg 1-3 Month U.S. Treasury Bill Index** is designed to measure the performance of public obligations of the U.S. Treasury that have a remaining maturity of greater than or equal to 1 month and less than 3 months.
- **Bloomberg U.S. Aggregate Index** covers the U.S. investment grade fixed rate bond market, with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities.
- **Bloomberg Global Aggregate ex. USD Indices** represent a broad-based measure of the global investment-grade fixed income markets. The two major components of this index are the Pan-European Aggregate and the Asian-Pacific Aggregate Indices. The index also includes Eurodollar and Euro-Yen corporate bonds and Canadian government, agency and corporate securities.
- **Bloomberg U.S. Corporate High Yield Index** covers the universe of fixed rate, non-investment grade debt.
