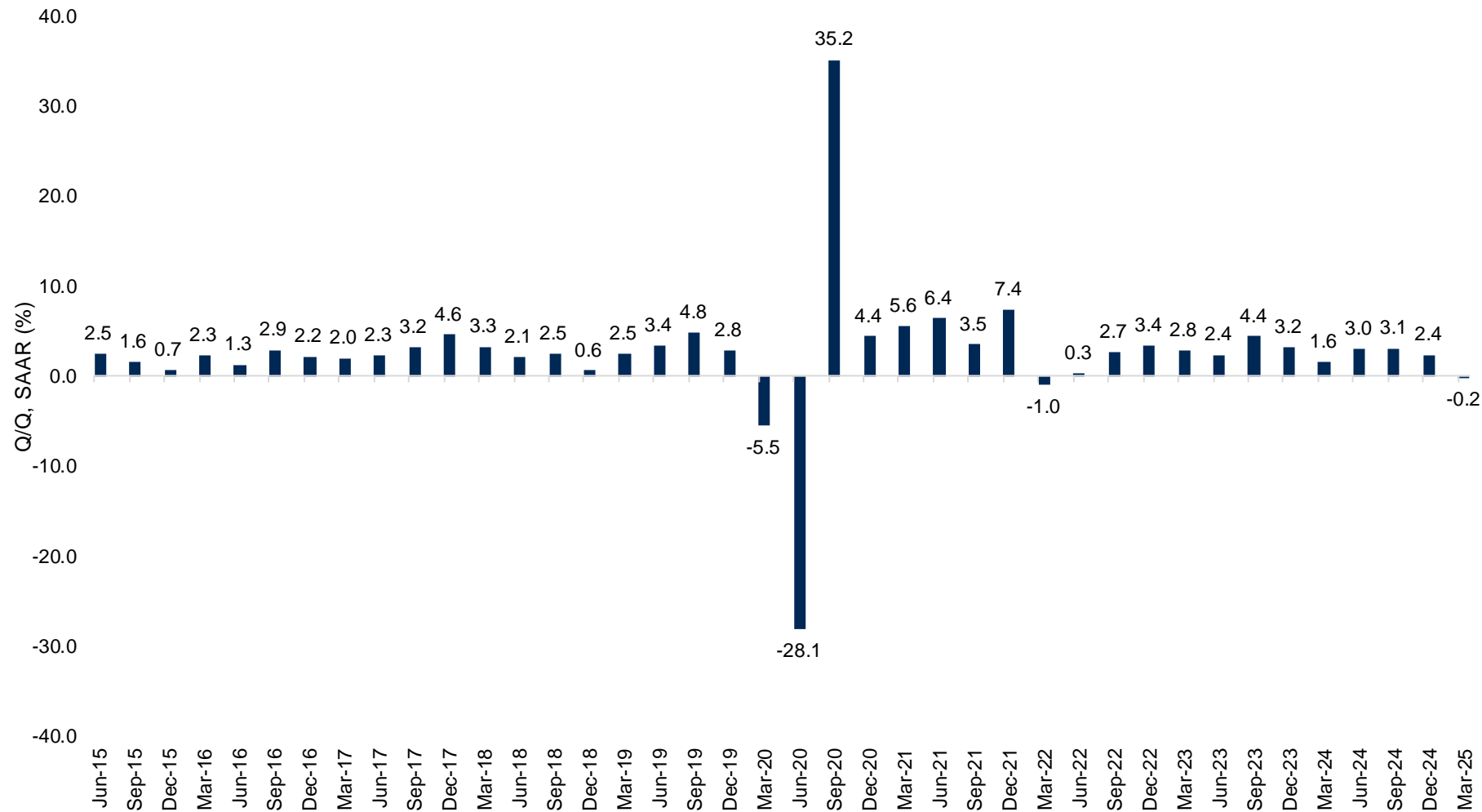

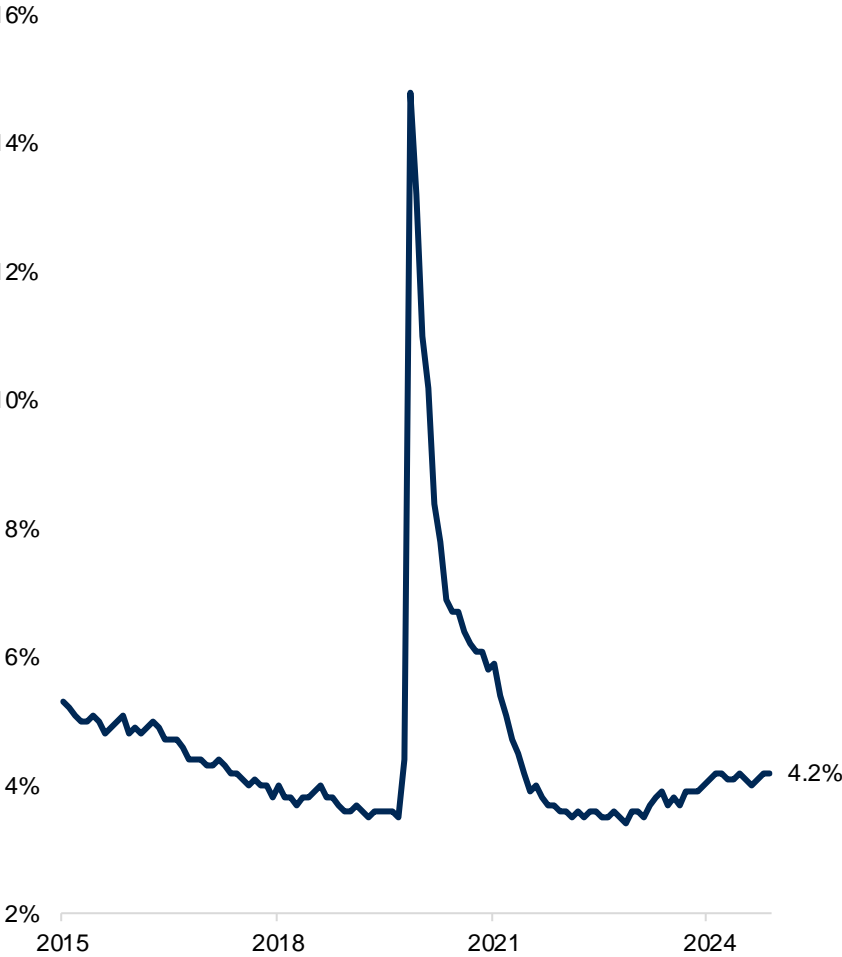
U.S. Real GDP Growth

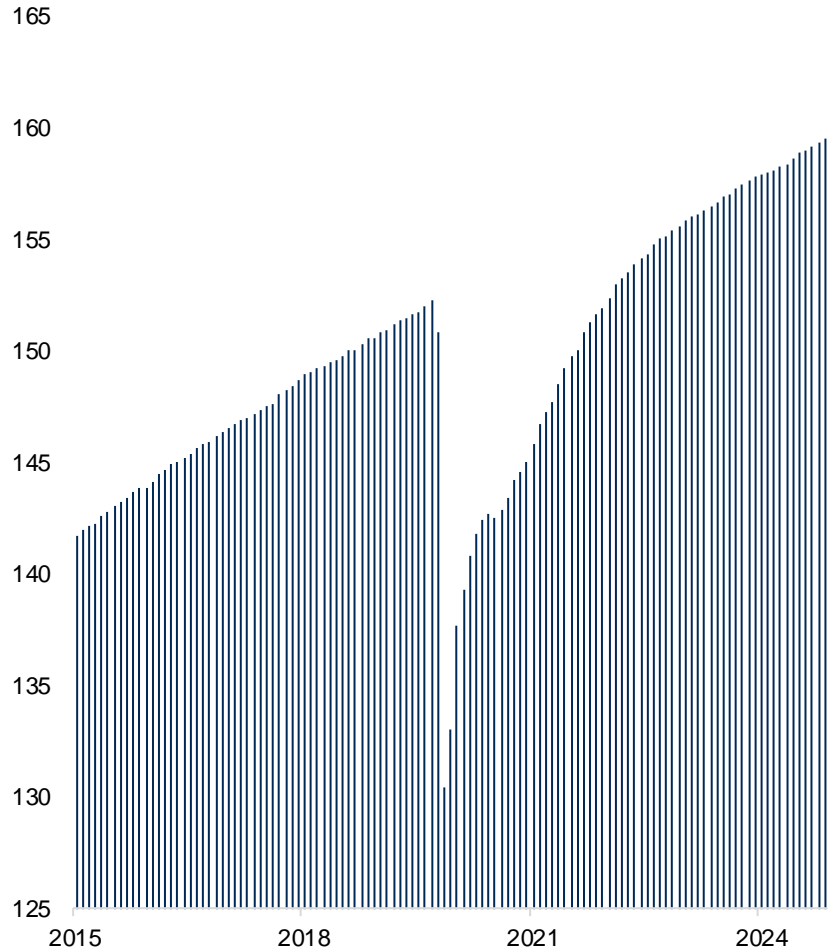
U.S. Labor Market

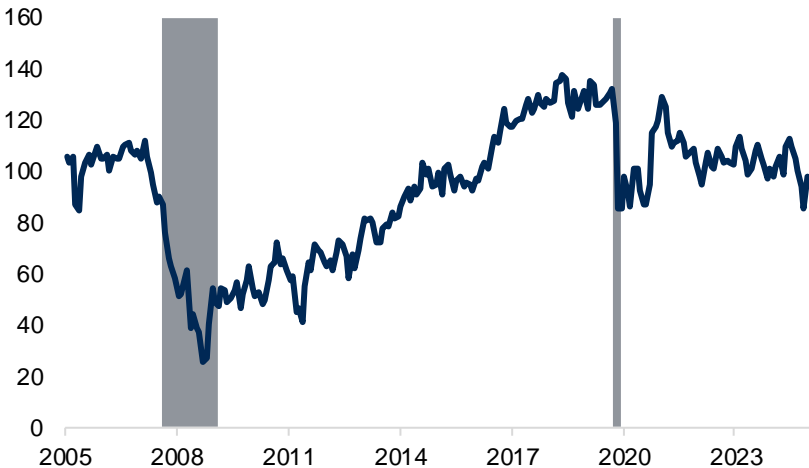

U.S. Leading Economic Indicator Index



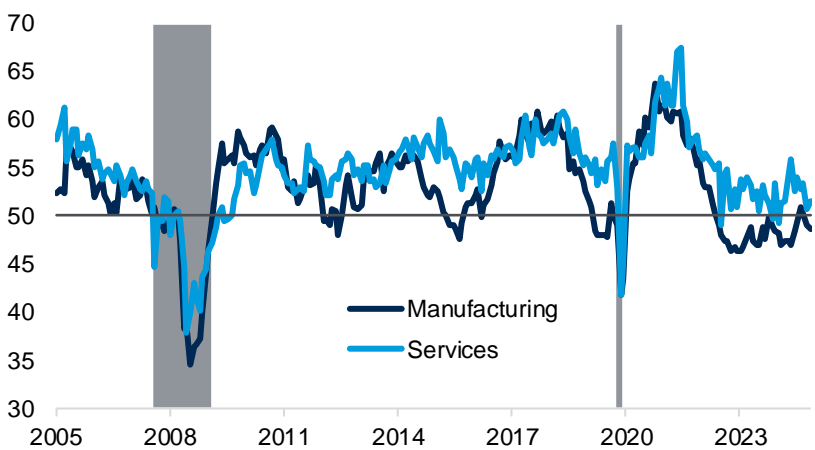

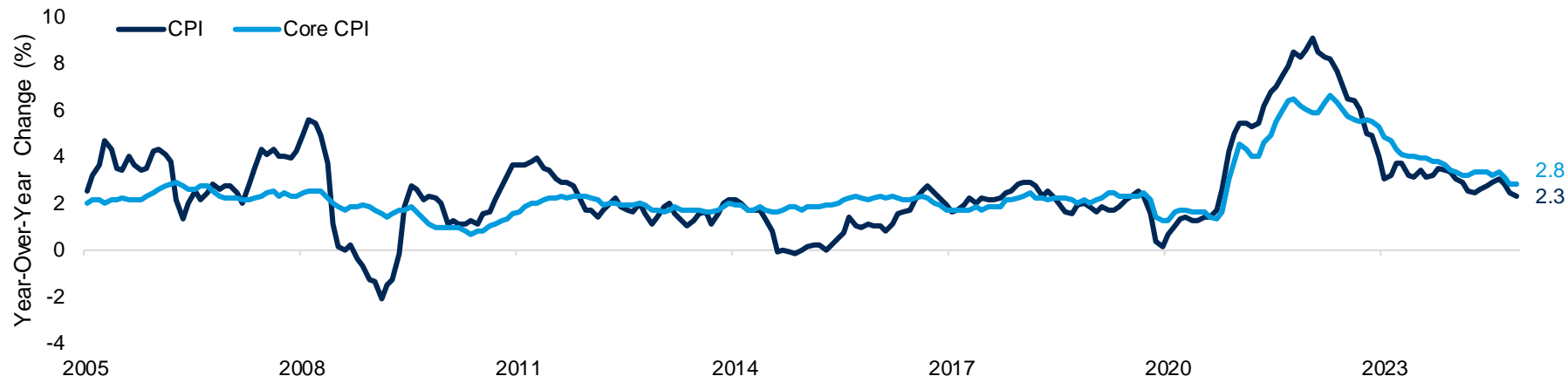
U.S. ISM PMI Levels

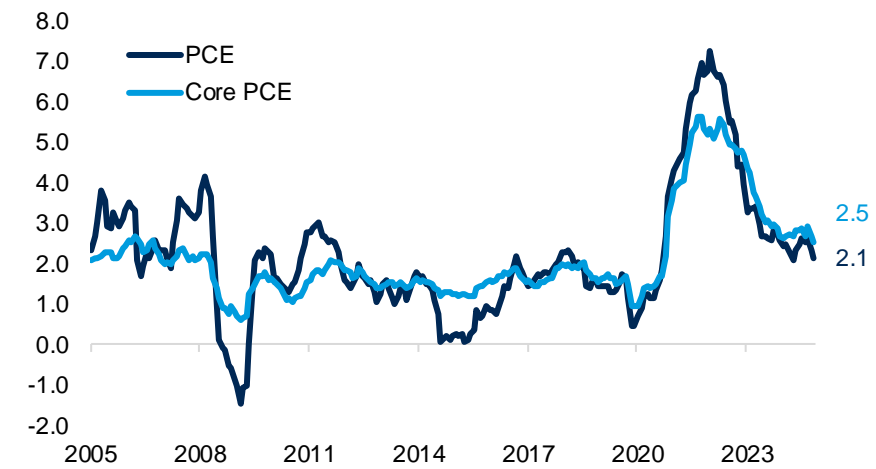

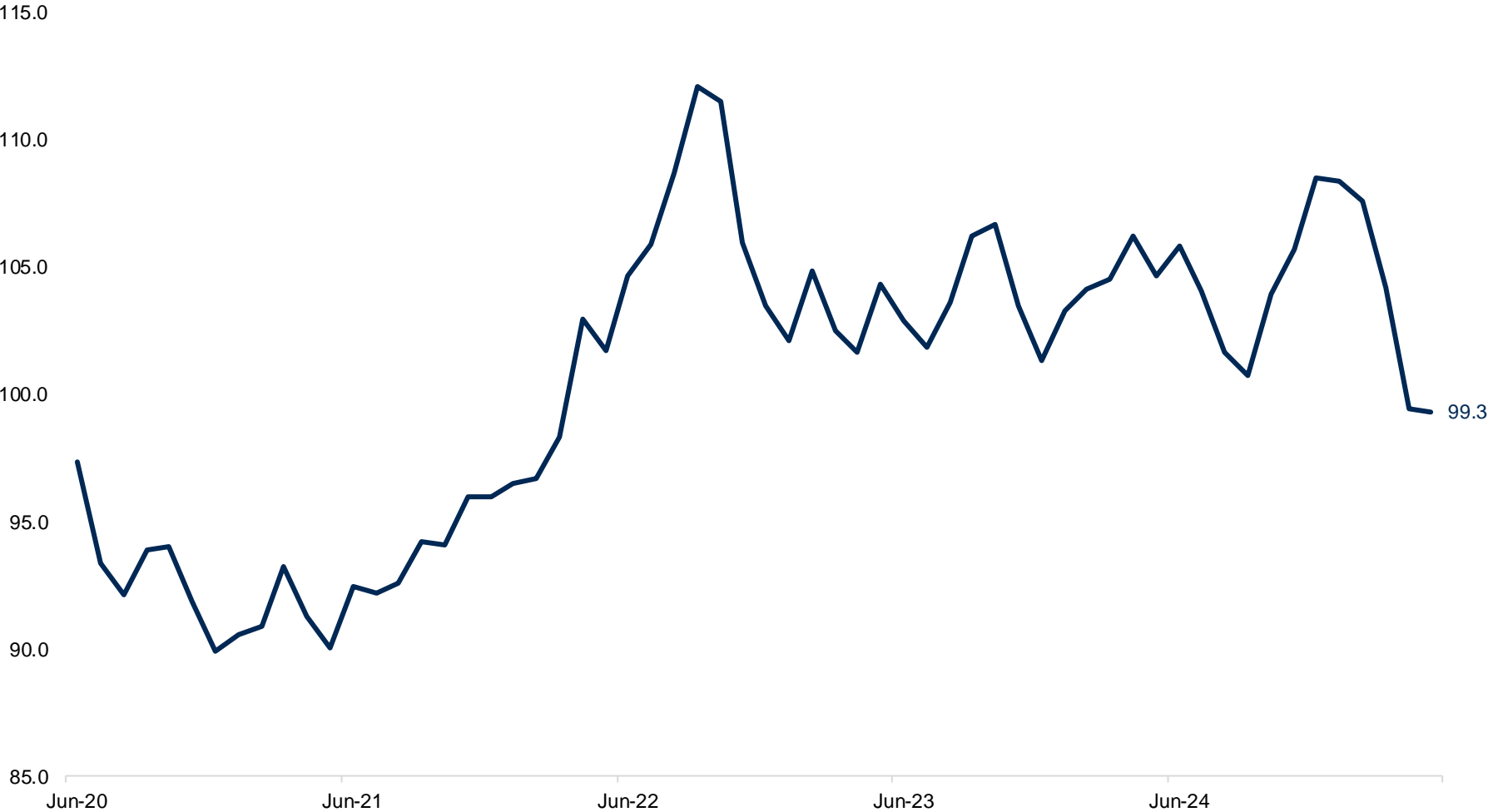
U.S. Breakeven Inflation

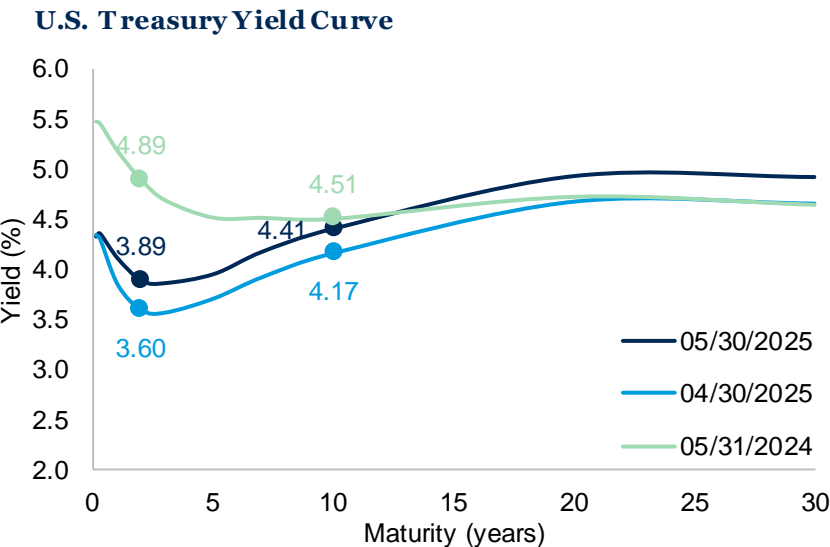

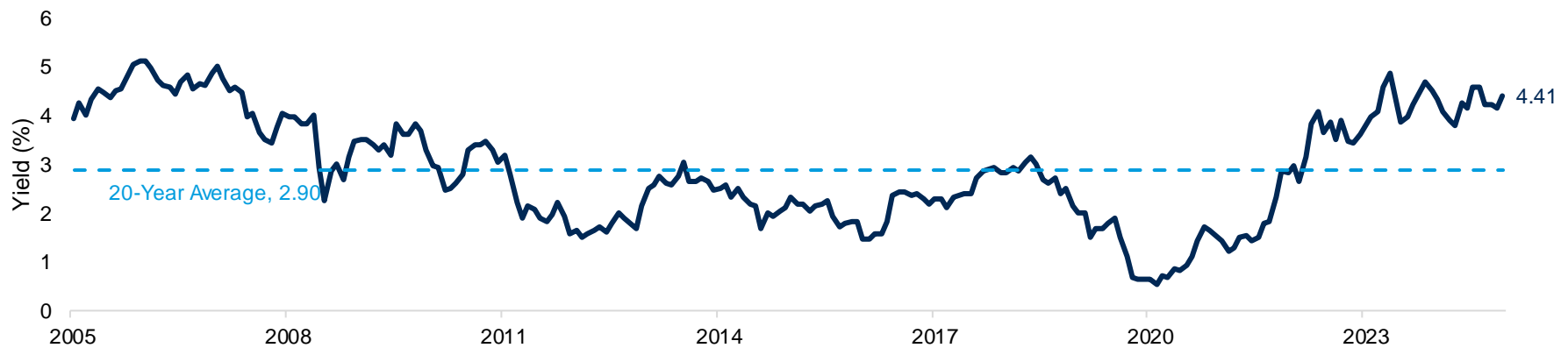

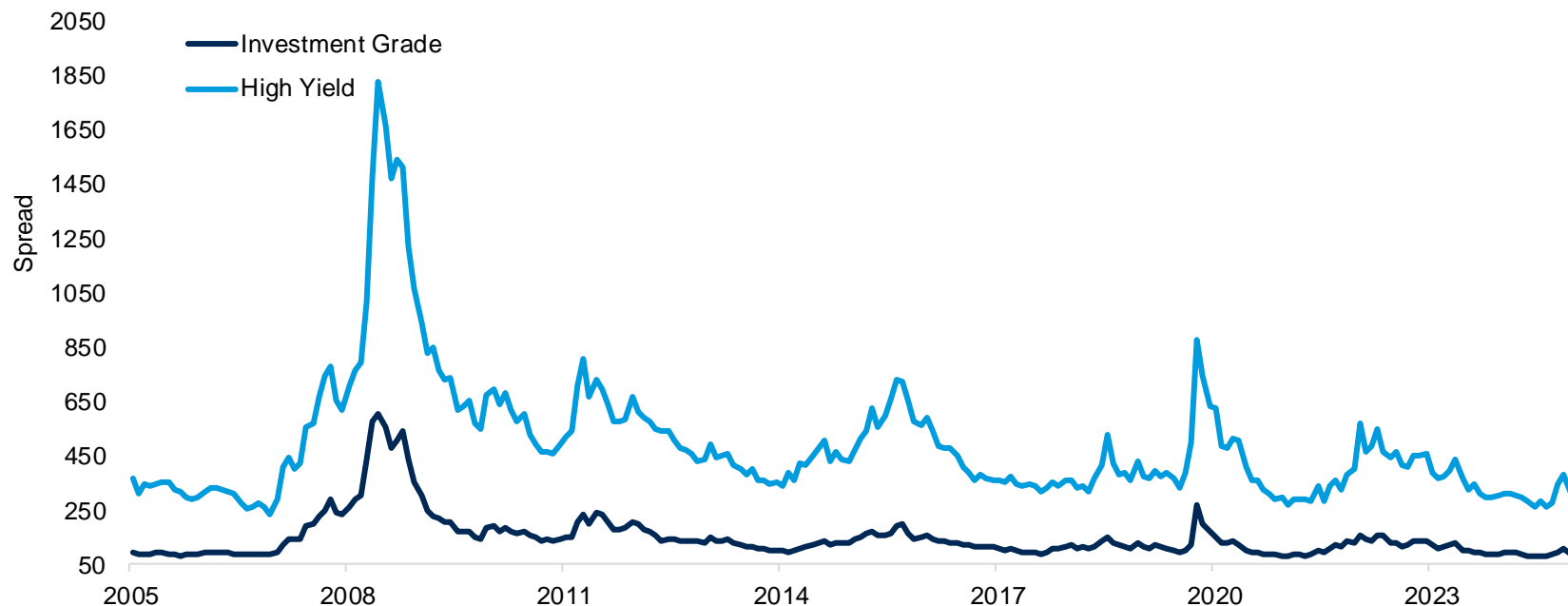
U.S. 10-Year Treasury Yield

Bloomberg Corporate Bond Index Spreads (bps)



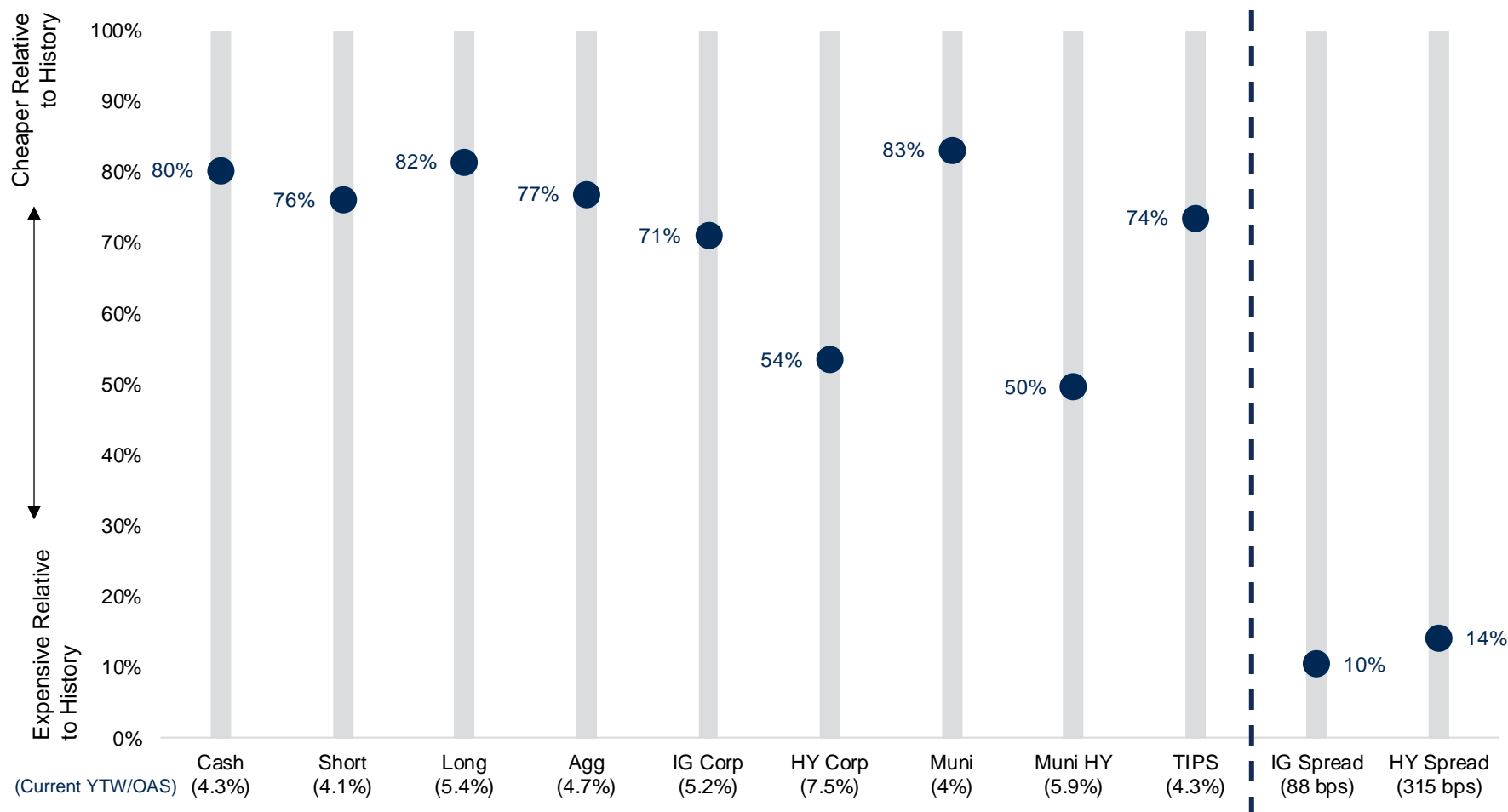

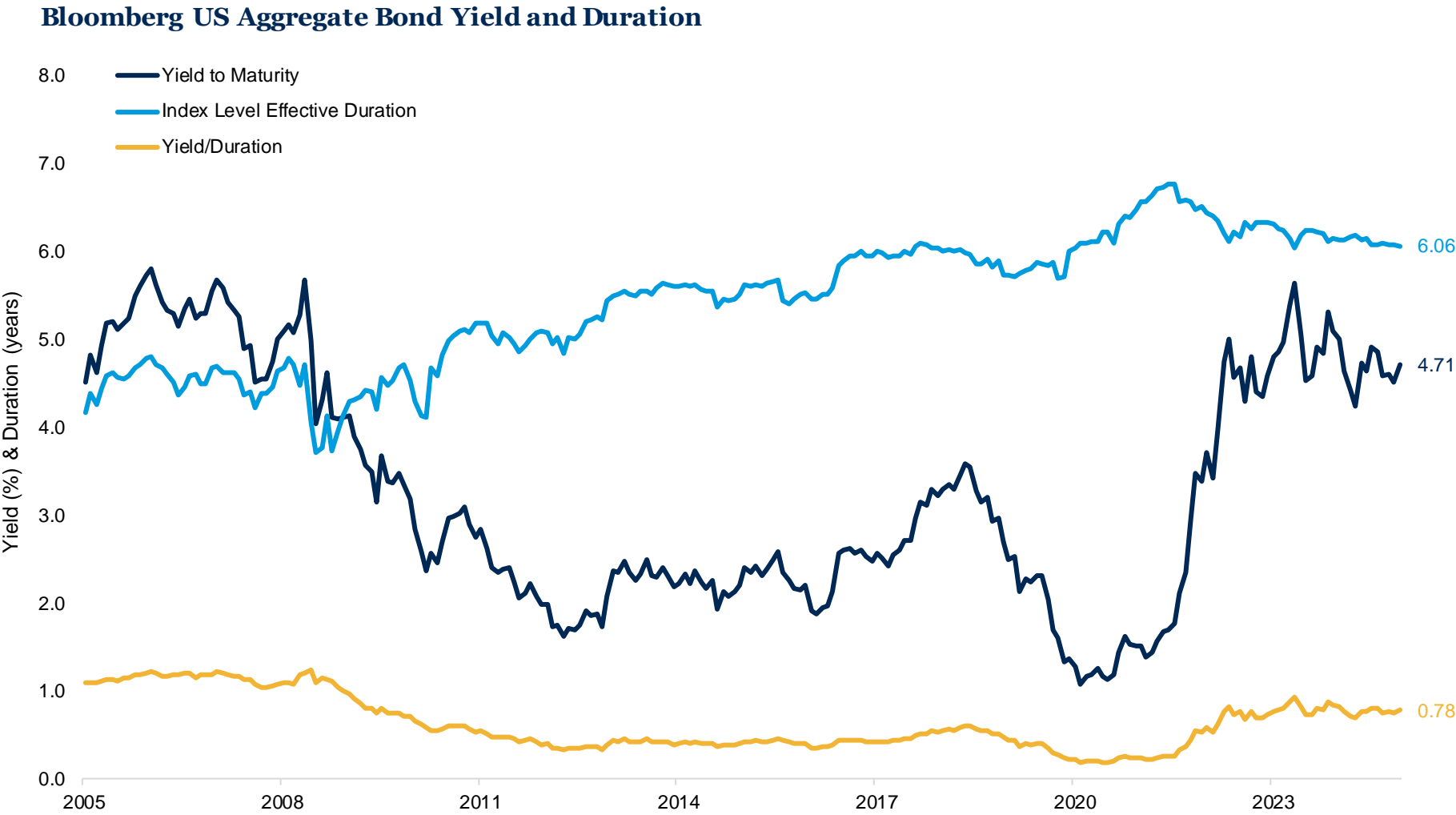
Yield and Spread Percentile Rank (last 20 years)

Bloomberg U.S. Aggregate Yield & Duration Profile

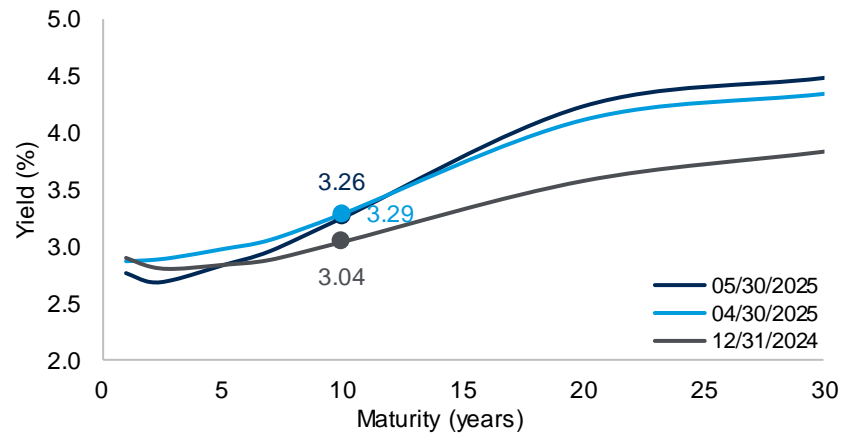

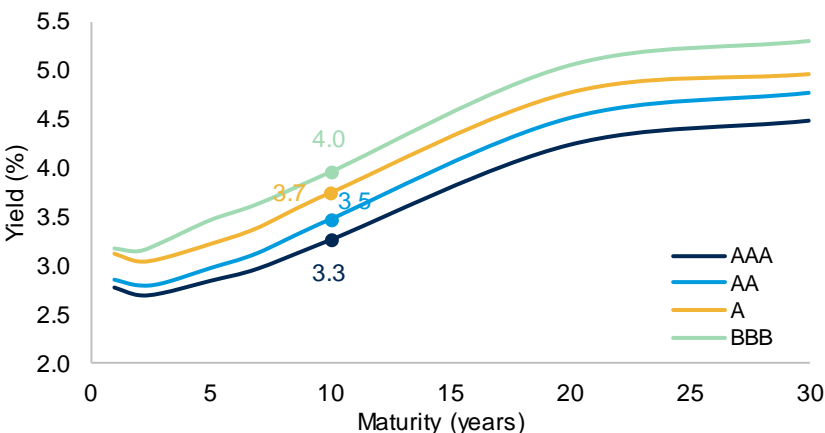

S&P AAA Muni Yield Curve



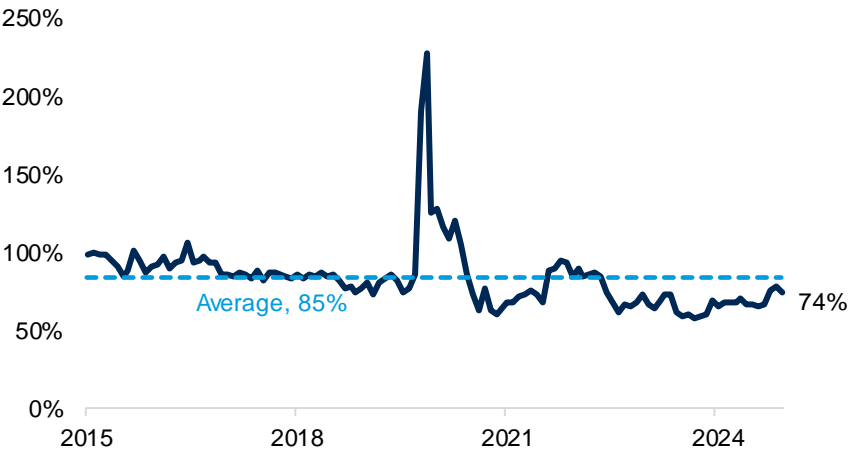

S&P U.S. Muni Curves



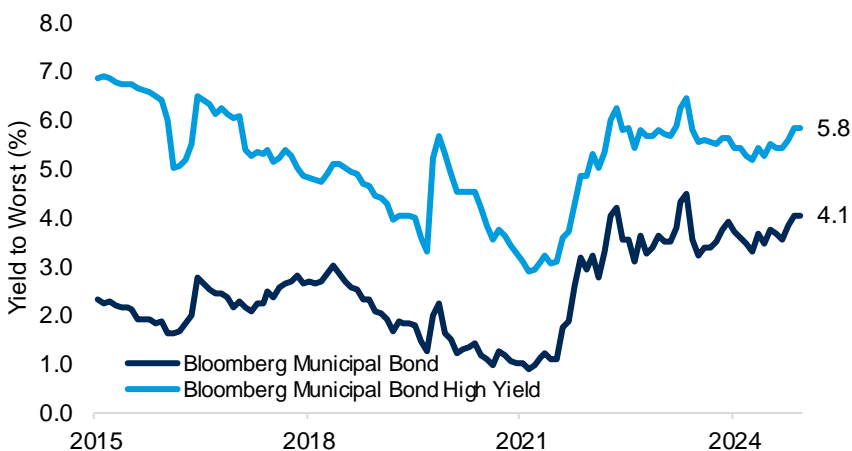

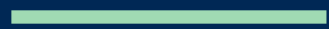
More Favorable Long-term Return Outlook for Fixed Income

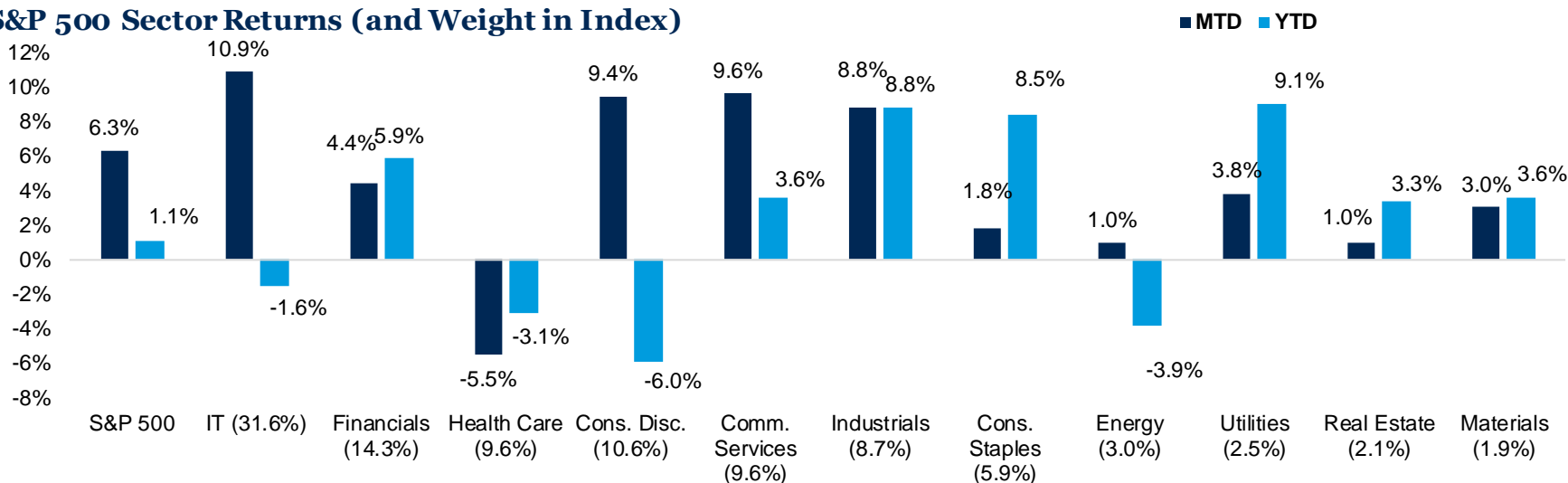

S&P 500 Sector Returns (and Weight in Index)

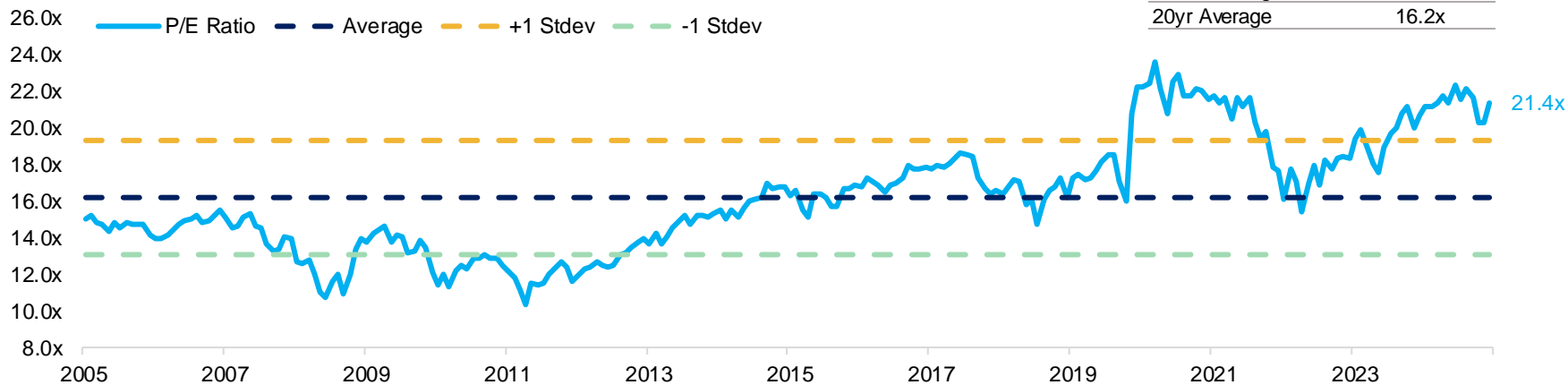

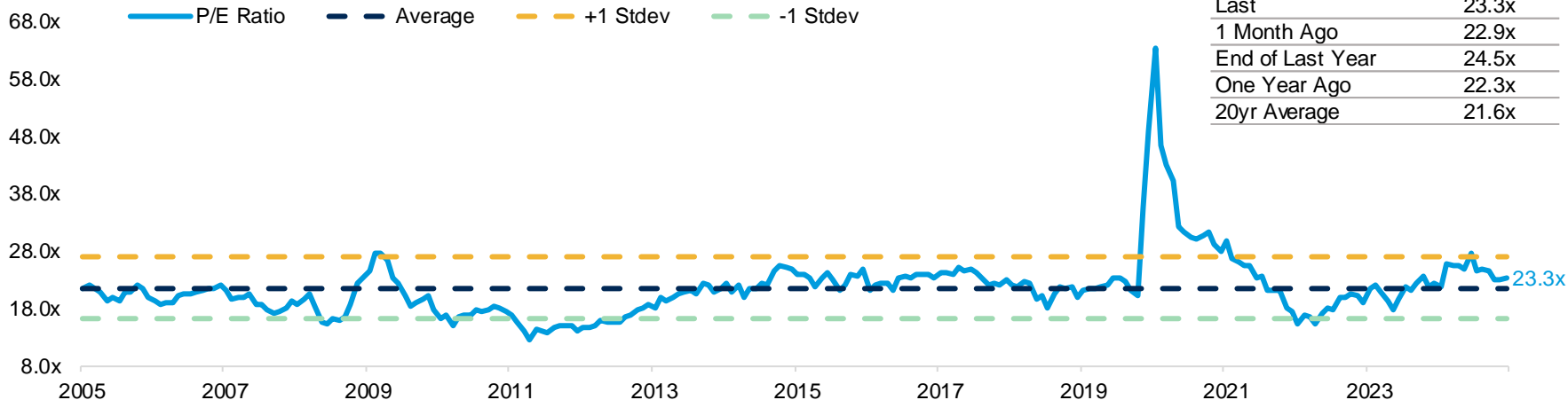

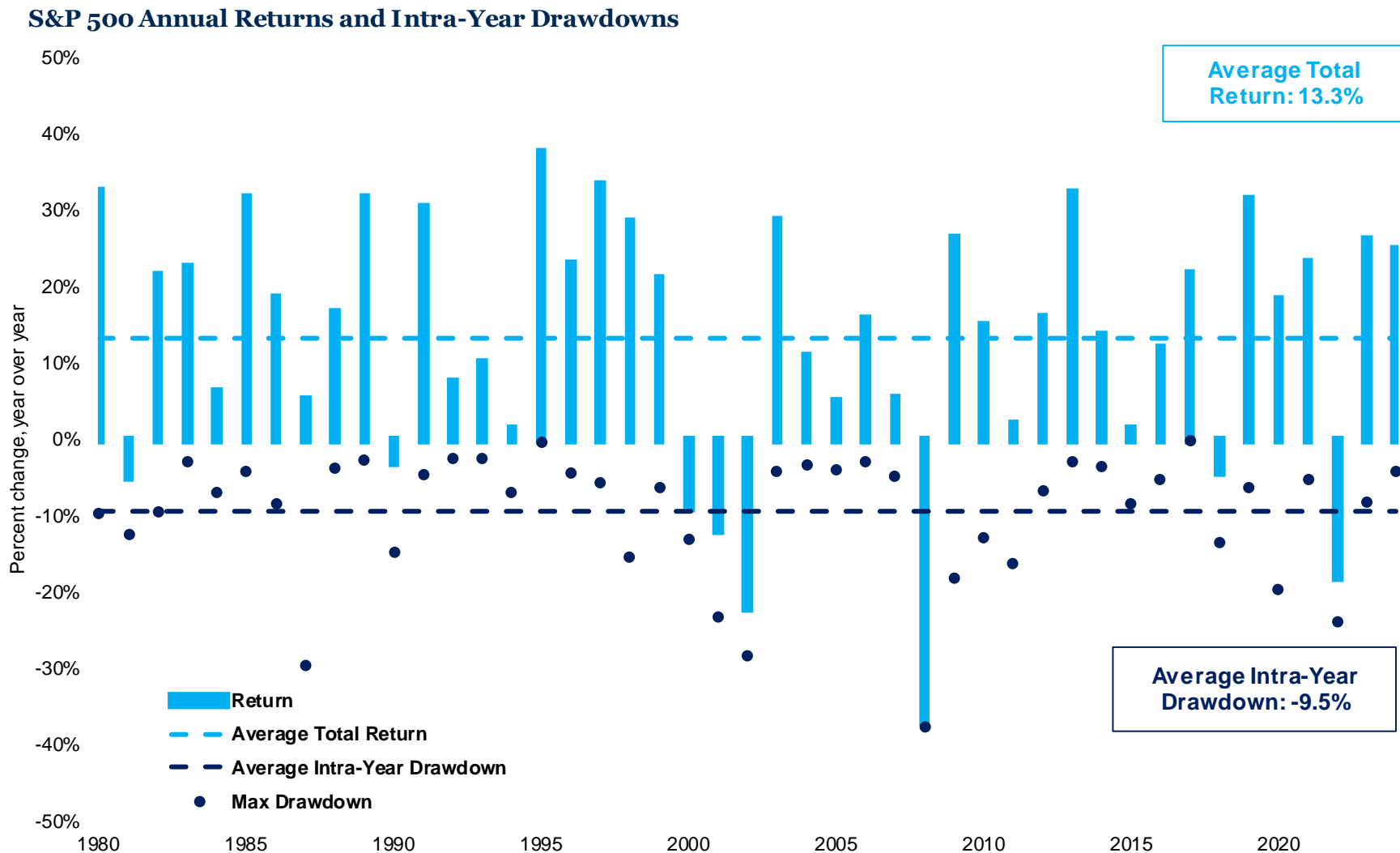
S&P 500 Earnings Decomposition

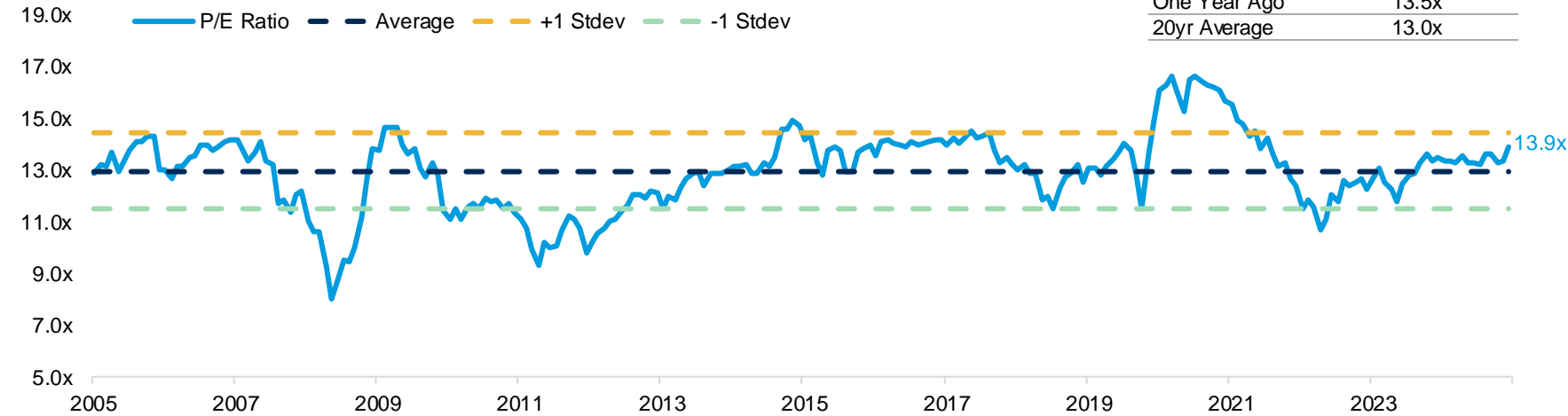

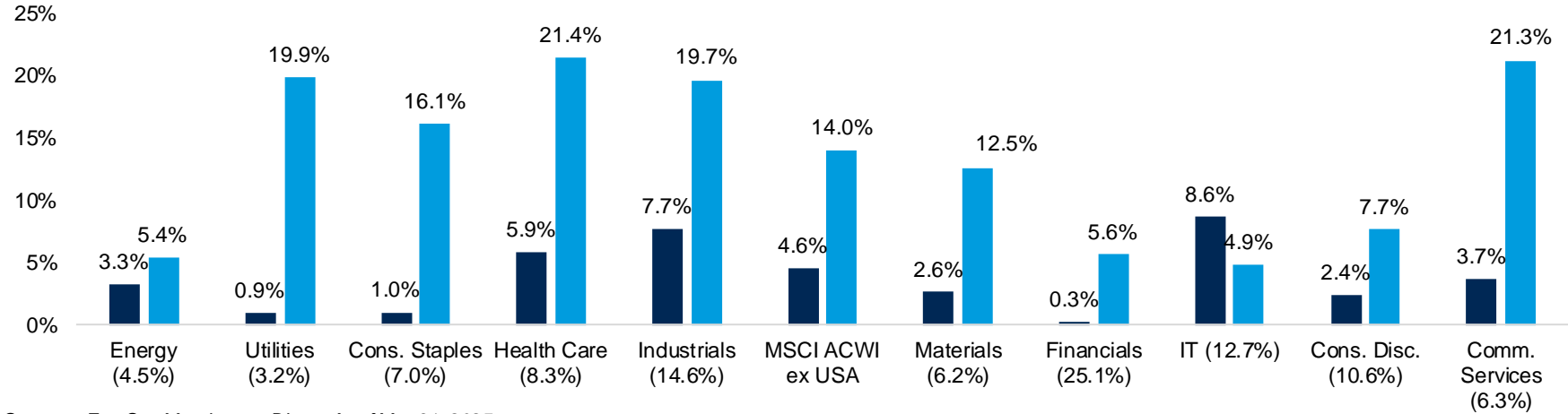

MSCI ACWI ex USA Sector Returns (and Weight in Index) ■ MTD ■ YTD

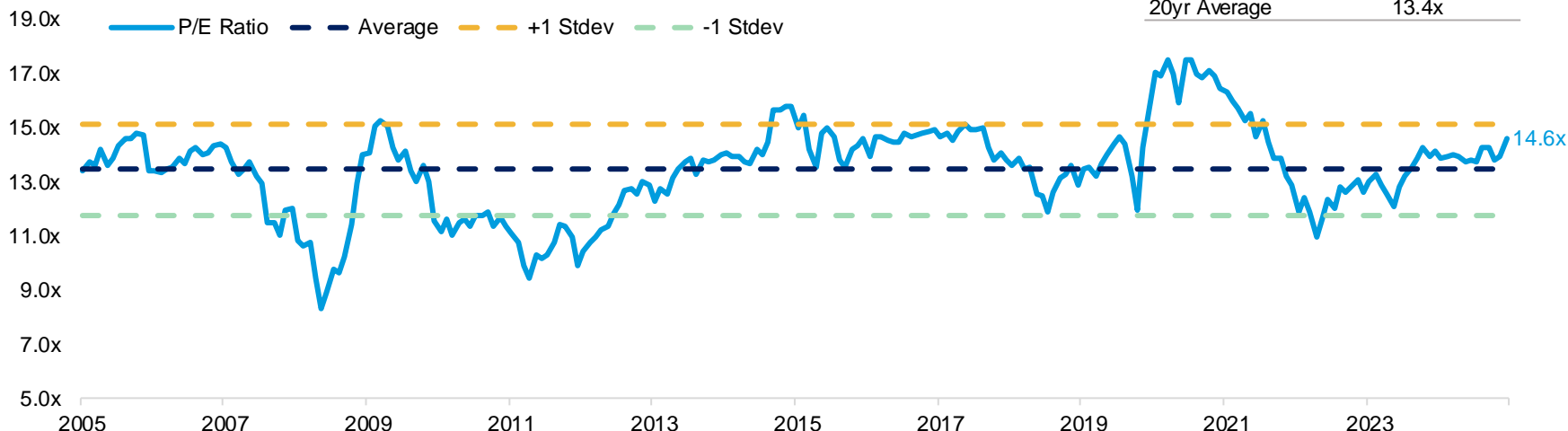

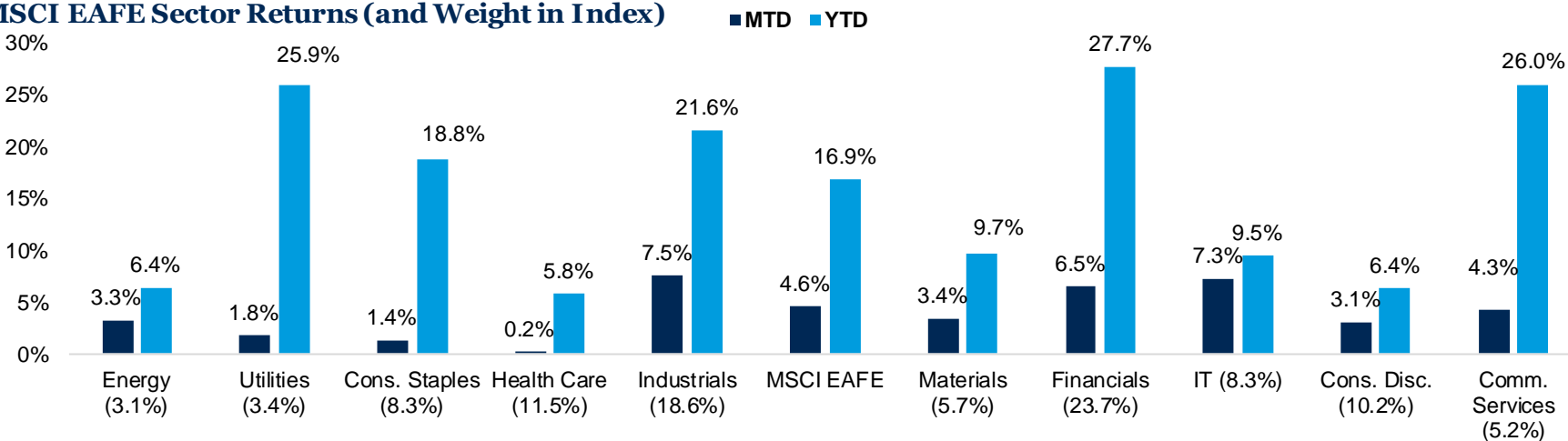
MSCI EAFE - P/E Ratio

MSCI EAFE Sector Returns (and Weight in Index)

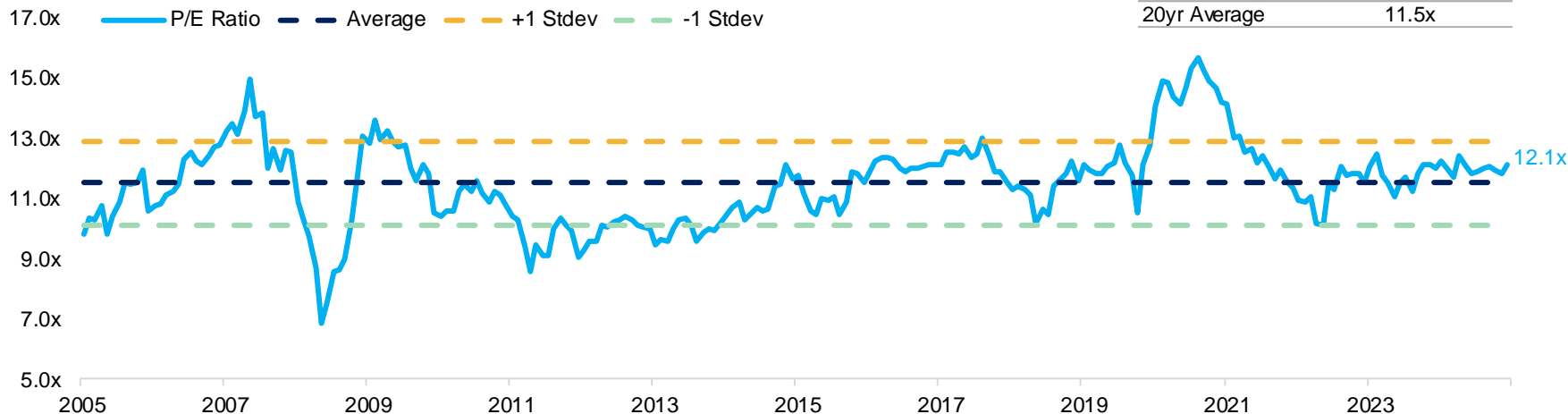

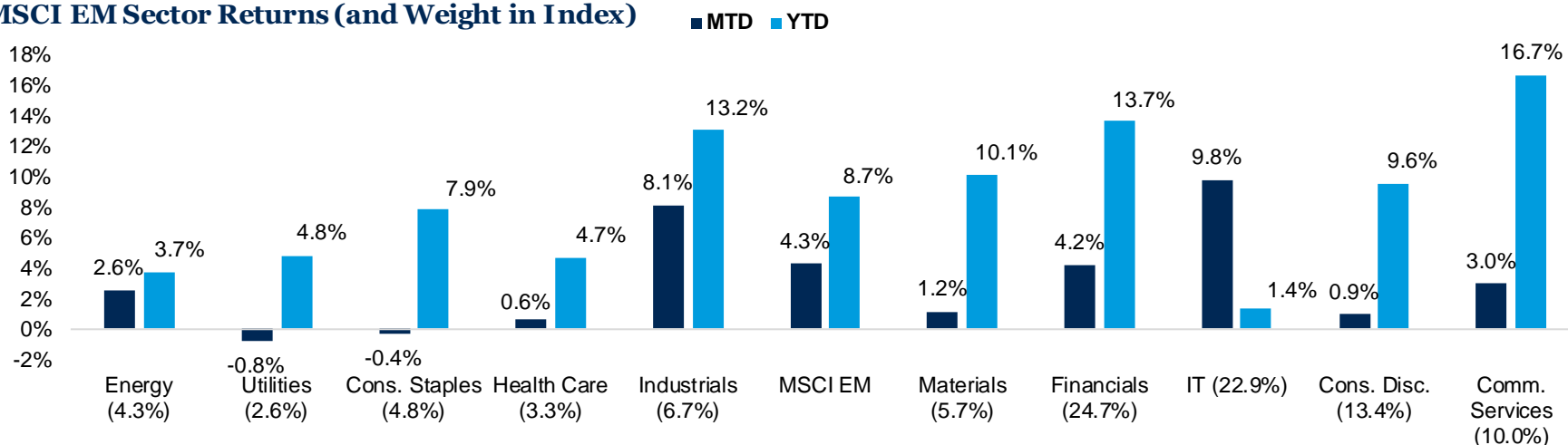
MSCI EM - P/E Ratio

MSCI EM Sector Returns (and Weight in Index)

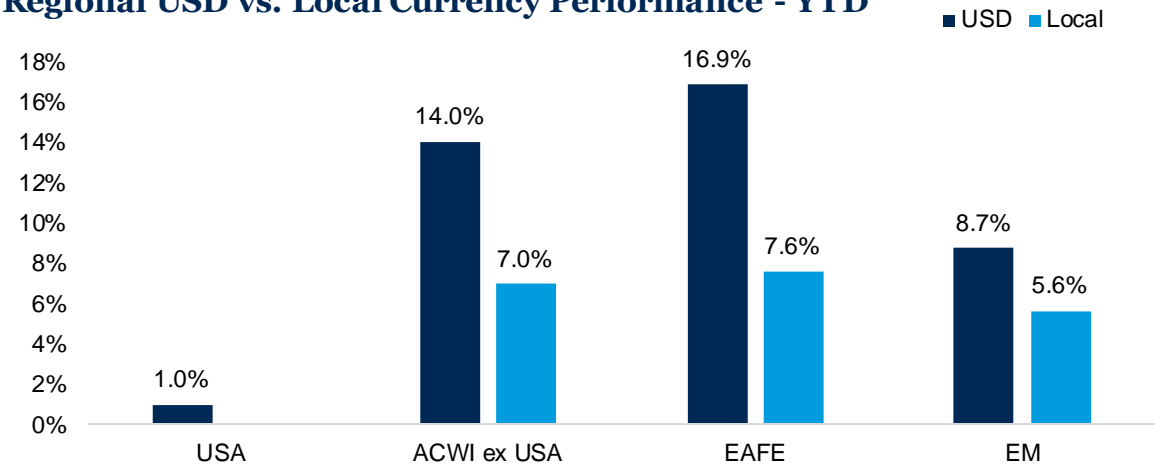

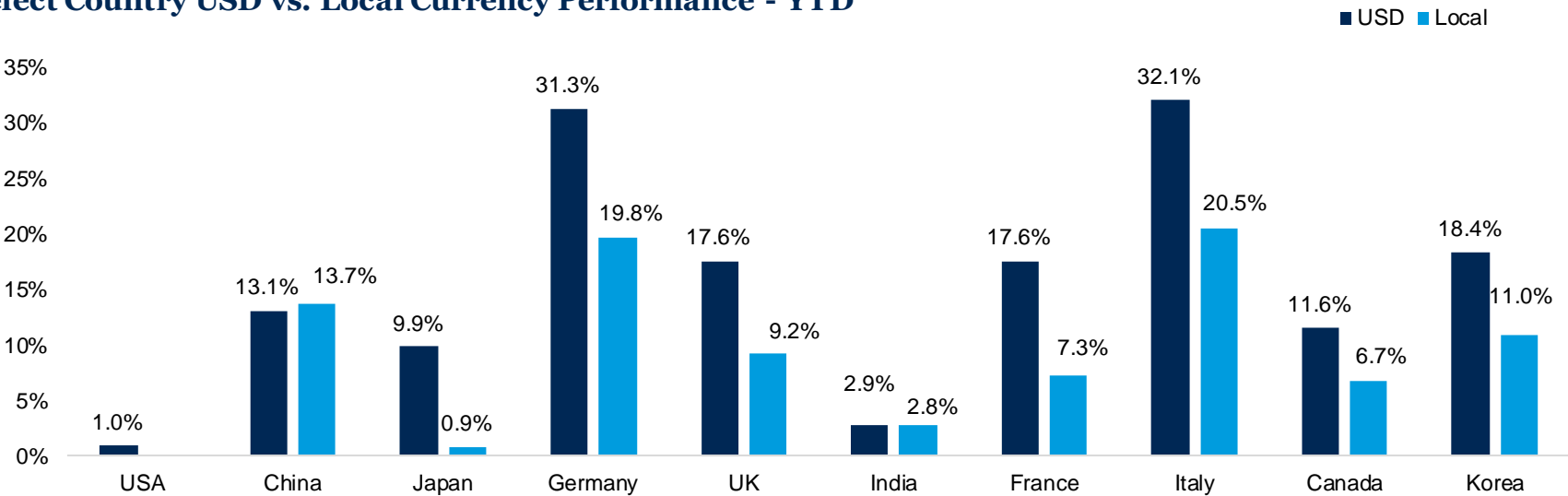
U.S. Dollar vs. Local Performance

Select Country USD vs. Local Currency Performance - YTD

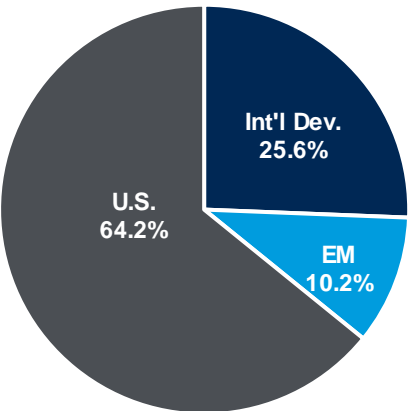

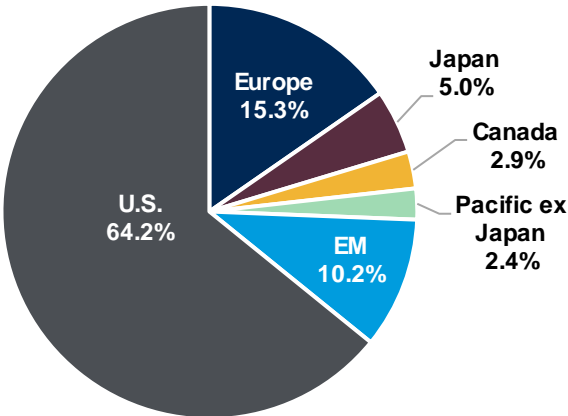

MSCI AC World Index Regions



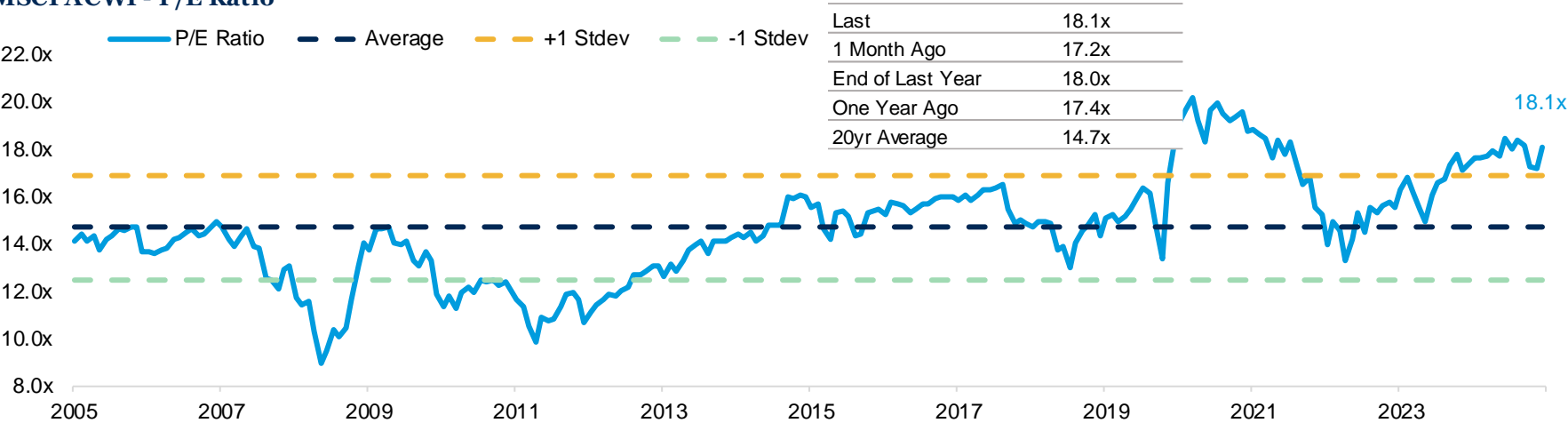

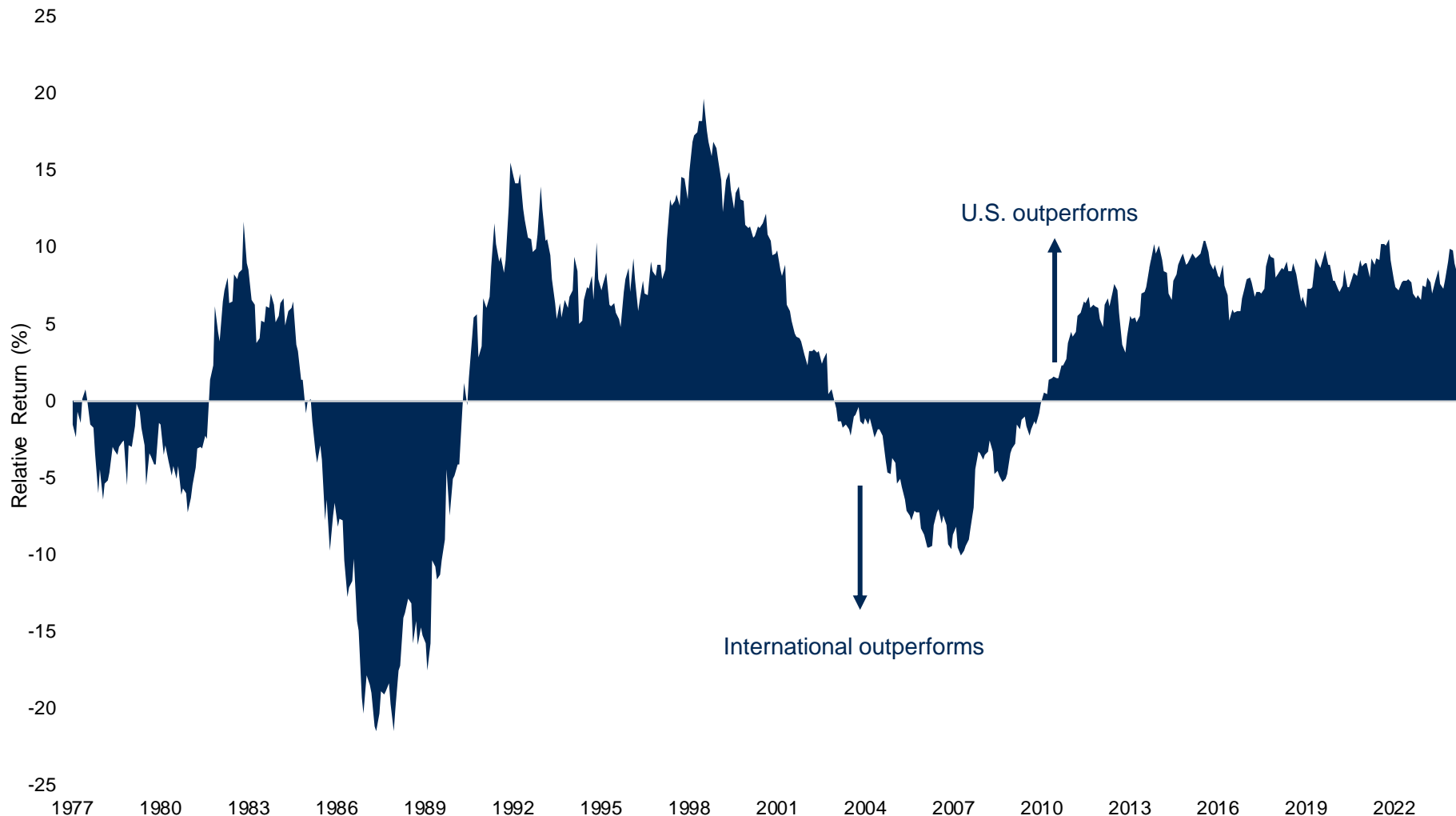

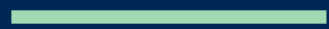
U.S. vs. International Performance

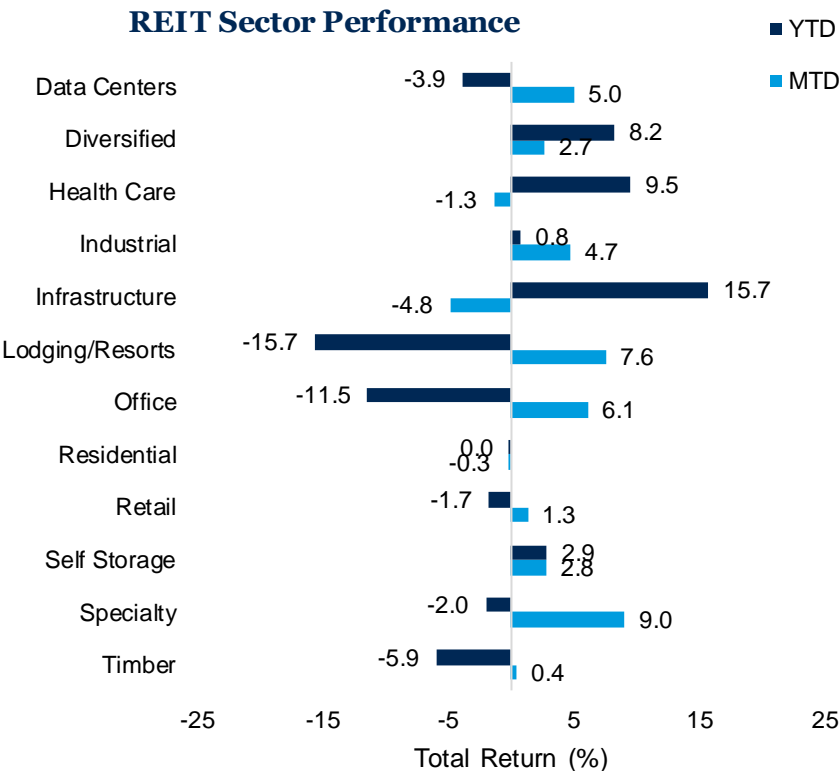

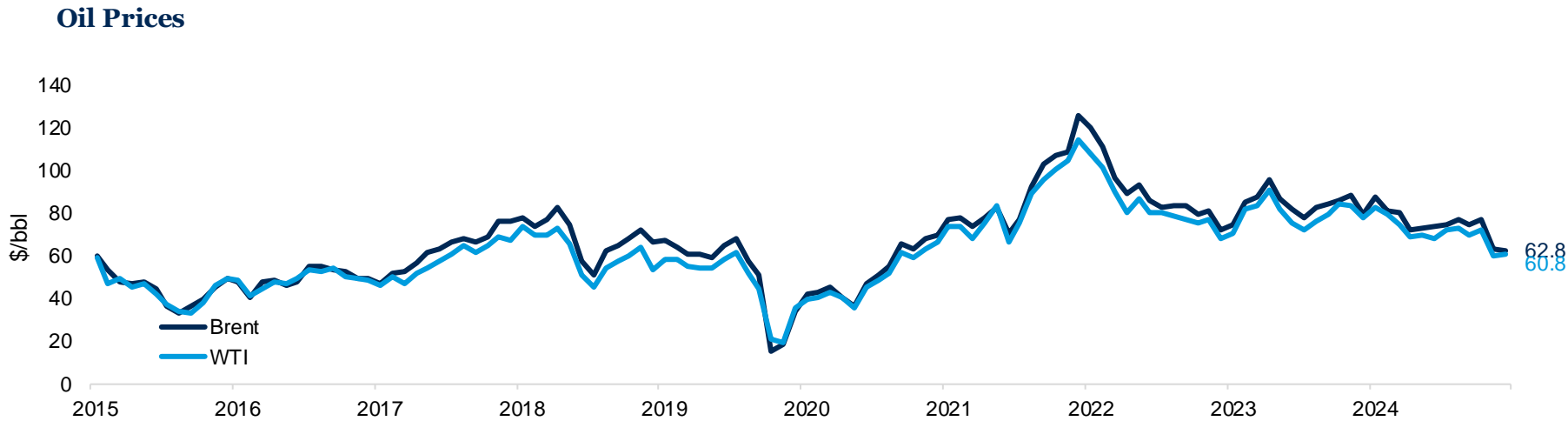

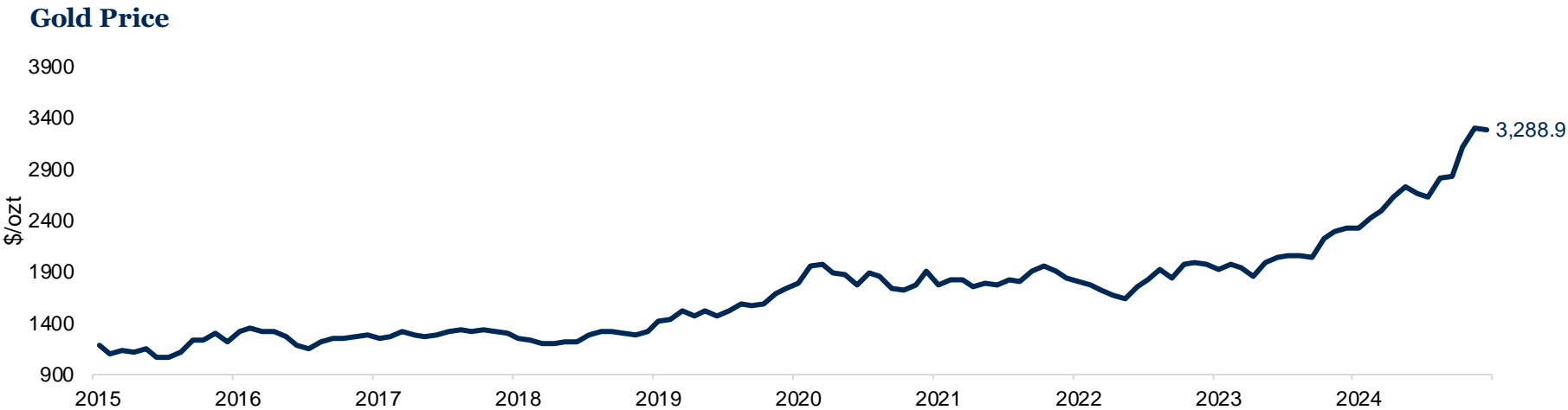
